**Fernando Ainsa**, critic and essayist, was born in Uruguay. Part of his work has been devoted to the study of the role of utopia in the history of Latin America: *Los buscadores de la utopía*, 1977; *Necesidad de la utopía*, 1989; *De la Edad de Oro a El Dorado. Génesis del discurso utópico*, 1992; *Historia, mito y utopía de la Ciudad de los Césares*, 1992; *La reconstrucción de la utopía*, 1999, and *Espacios de encuentro y mediación. Sociedad civil, democracia y utopía en América Latina*, 2004. He worked at UNESCO between 1972 and 1999 as literary director of Éditions de l'UNESCO.
