The *MATHEMATICAL SCIENTIST* (CSIRO/Australian Mathematical Society) began publication in 1976. It publishes papers of general interest and papers of interest to scientists involved in the application of mathematics. One volume of two parts will be published in 1986. The price to non-members is A\$15.00 (US\$13.00) for 1986. Typescripts for publication should be sent to the Editor, Professor B. C. The *GAZETTE* started publication in 1974 and carries news items, mathematical articles of general interest, and articles on tertiary mathematics teaching.
