### WOMEN IN PSYCHIATRY

DEAR SIR,

I was interested in Dr. Dorothy Black's letter on this subject and dismayed by her final sentence. I do not think that psychiatry is unwelcoming to women. Thirty years' experience has given me the impression that women excel in psychiatry. I think it is a little unfair to call the specialty rigid. The difficulty is surely in accommodating part-timers, regardless of sex. The psychiatric patient relates to one person, and even when there is a whole-time team there are difficulties which do not arise in subjects such as

general medicine and general surgery. To be somewhat facetious, one might make the counter-charge that it is the women who are somewhat rigid in demanding, in such a high proportion of cases, part-time appointments. More seriously, the constraints result from the patients' needs and not from the desires of either women, psychiatrists, or employing authorities. If this is forgotten we may make poor decisions.
