LAWRENCE M. FRIEDMAN is Professor of Law at Stanford University. He is the author of *A History of American Law* (1973), *The Legal System: A Social Science Perspective* (1975), and other studies in the history and sociology of law.

ROBERT W. GORDON, Associate Professor of Law at the State University of New York at Buffalo, attended Harvard College and the Harvard Law School. He is currently working on studies of 19th century legal thought and practice and of contemporary legal historiography.

MARK H. HALLER, Professor of History at Temple University, is serving this year as a Visiting Fellow at the National Institute of Law Enforcement and Criminal Justice in Washington, D.C. He is completing a book on the history of crime and criminal justice in Chicago, and his current research involves a comparative study of the history of crime in American cities during the past century. He has published a number of articles based on his research.

CHARLES W. McCURDY is Acting Assistant Professor of History at the University of Virginia. He spent 1973-1975 at the Yale Law School as a Russell Sage Fellow in Law and Social Science, and is currently completing his Ph.D. in United States history at the University of California, San Diego. Last year he received the Organization of American Historians' Pelzer Award for an essay on Mr. Justice Field's jurisprudence of government-business relations.

WILLIAM E. NELSON is Associate Professor of Law at Yale University. He was graduated from New York University Law School (LL.B.) and Harvard University (Ph.D. in History), and served as a law clerk to Justice Byron R. White of the U.S. Supreme Court. He is the author of *Americanization of the Common Law: The Impact of Legal Change on Massachusetts Society, 1760-1830* (1975), and is currently at work on a book on 19th century American law.

ROBERT V. PERCIVAL is a graduate student in the Department of Economics at Stanford University and, in addition, a student at the Law School. He is on the editorial board of the *Stanford Law Review*, and is currently engaged in research on the criminal justice system.

HARRY N. SCHEIBER is Professor of History in the University of California at San Diego. He is the author of *The Wilson Administration and Civil Liberties, 1917-21* (1961), *Ohio Canal Era: A Case Study of Government and the Economy, 1820-1861* (1969) and of many articles on public policy, transportation, entrepreneurship, and land policy in the 19th century. He embarked on studies in the history of law and the economy while a Fellow of the Center for Advanced Study in the Behavioral Sciences (Stanford) in 1966-67. He is currently working on a history of eminent domain and property law in the United States, and on a major historical study of American federalism.

MARK V. TUSHNET is Assistant Professor of Law at University of Wisconsin (Madison). A graduate of Harvard (B.A.) and Yale (J.D. and M.A. in history), he was law clerk to Judge George Edwards, U. S. Court of Appeals for the Sixth Circuit, and to Justice Thurgood Marshall of the U.S. Supreme Court. He has written articles on current issues in Constitutional law and the law of federal courts, and on legal history (including an analysis of the work of Willard Hurst in 1972 *Wisc. L. Rev.* 114). Among his current research projects is a study of the work of Justice Holmes on the Supreme Judicial Court of Massachusetts.
