CARLOS SEMPAT ASSADOURIAN is Professor of History at the Colegio de México in Mexico City. He is best known for his work on the colonial economy in Latin America and the economic problems of independence.

ELIANA CARDOSO is Associate Professor of Economics at the Fletcher School at Tufts University and Research Associate of the National Bureau of Economic Research. She has published widely on Latin American economic issues.

ROBERTO CORTÉS CONDE is Professor of Economic History, Universidad de San Andres, Buenos Aires, Argentina, and Tinker Visiting Professor, University of Chicago 1991–2. His most recent book is *Dinero, deuda y crisis*.

ALBERT FISHLOW is Class of 1959 Professor of Economics and Dean of International and Area Studies at the University of California at Berkeley. He has published extensively on issues of Latin American development.

TULIO HALPERÍN DONGHI is Professor of History, University of California, Berkeley. He has also taught at the Universities of Rosario, Buenos Aires and Oxford. His most recent book is *El espejo de la historia*.

ALAN KNIGHT teaches history in the University of Texas at Austin. From October 1992 he will be the Director of the Latin American Centre at Oxford and a Fellow of St Antony's College. He has published extensively on Mexico in the twentieth century.

JOHN LYNCH is Emeritus Professor of Latin American History and was formerly Director of the Institute of Latin American Studies, University of London. He is spending 1991–2 as Harrison Professor, College of William and Mary, Williamsburg.

FLORENCIA E. MALLON teaches Latin American history at the University of Wisconsin-Madison. She is the author of articles on peasant politics and consciousness, and on women and the transition to capitalism.
