

ABOUT THE AUTHORS

LESTER BRICKMAN is a Professor of Law at the University of Toledo and is currently on leave at the Benjamin N. Cardozo School of Law of Yeshiva University. He holds a B.S. degree from Carnegie-Mellon, a J.D. from the University of Florida, and an LL.M. from Yale. His areas of concentration are professional responsibility, legal services delivery systems, clinical legal education, and law and poverty. He has been a consultant to the Office of Legal Services, the ABA (legal clinics and specialization), the Ford Foundation (legal paraprofessionals), and the Council on Legal Education for Professional Responsibility (clinical legal education). His writings have principally concerned the legal services delivery system, including such topics as lawyers' advertising, group and prepaid legal services, the right to counsel in civil cases, specialization, paraprofessionals, and lawyer competence. He is presently working on a set of teaching materials for a course in Professional Responsibility.

RICK J. CARLSON, a lawyer by training, graduated from the University of Minnesota Law School and served as a research attorney for InterStudy in Minneapolis. He was a visiting fellow at the Center for the Study of Democratic Institutions in Santa Barbara, California, and now lives near San Francisco, working as an itinerant writer and consultant. He is a Senior Associate at the Institute of Medicine of the National Academy of Sciences, and a Research Associate at the Institute for the Study of Human Knowledge in Palo Alto, California. His publications include *The End of Medicine* (1974) and *The Frontiers of Science and Medicine* (1975).

MARC GALANTER is Professor of Law at the State University of New York at Buffalo, currently visiting at the University of Wisconsin. He is a former editor of the *Law & Society Review*, and has written extensively on the legal system and the structure of legal representation.

JACK LADINSKY received his Ph.D. in sociology from the University of Michigan in 1962. He is currently a Professor of Sociology at the University of Wisconsin and a Research Fellow in the University's Institute for Research on Poverty. He served on the latter's New Jersey Negative Income Tax Project. He has extensive experience in research on the legal profession and on the provision of legal services to the poor. In addition to law, his current research is on Vietnam veterans and on the police. He was a consultant on veterans affairs to the Bureau of Management and Budget in 1969, and is currently a consultant to The Police Foundation.

RICHARD O. LEMPert, a Professor of Law at the University of Michigan Law School, holds a J.D. degree and a Ph.D. in sociology, both from the University of Michigan. His primary interest is in the sociology of law and he has published articles in *The American Sociological Review* and the *Michigan Law Review*, as well as in the inaugural issue of the *Law & Society Review*. Recently he has been concerned with the social psychology of the jury system and he has completed (with Professor Stephen Saltzburg of the University of Virginia Law School) and evidence coursebook entitled *A Modern Approach to Evidence*.

F. RAYMOND MARKS received his A.B. degree from Washington University in 1947 and his J.D. from the University of Chicago in 1952. From 1964-73 he was a Professional Lecturer at the Graduate School of Business and School of Social Service Administration of the University of Chicago. He was a Research Attorney with the American Bar Foundation from 1968-73 and since then he has been an Affiliated Scholar. His American Bar Foundation publications include *The Legal Needs of the Poor: A Critical Analysis* (1971), *The Lawyer, the Public, and Professional Responsibility* (1972), and *The Shreveport Plan: An Experiment in the Delivery of Legal Services* (1974). Currently a Research Attorney with the Childhood and Government Project at the School of Law of the University of California, Berkeley, he has been there since 1972.
