A sociologist, **CECILIA GREEN** taught in the areas of gender, labor, global political economy, and Caribbean studies at the University of Michigan, Ann Arbor, for several years. She is now teaching in the Department of Ethnic Studies of Bowling Green State University. She has written a book as well as several articles on these interrelated subjects. Her geographical area of specialization is the English-speaking Caribbean.

MARC EDELMAN is Professor of Anthropology at Hunter College and the Graduate Center of the City University of New York. His books include *The Logic of the Latifundio: The Large Estates of Northwestern Costa Rica since the Late Nineteenth Century* and *Defying the Invisible Hand of the Market: Costa Rican Peasants Confront the Global Economy* (forthcoming).

ELISABETH J. FRIEDMAN is Assistant Professor of Political Science at Barnard College, Columbia University. She is currently completing a book on women's organizing in twentieth-century Venezuela, to be published by Pennsylvania State University Press.

DARIO CANTON teaches as a member of the Facultad de Ciencias Sociales at the Universidad de Buenos Aires. His current research, in collaboration with Jorge Raúl Jorrot, focuses on elections in the city of Buenos Aires throughout the twentieth century. He has written two books on related subjects and coauthored a third with Jorrot, *La investigación social hoy: A cuarenta años de la recreación del Instituto de Sociología* (UBA, 1997).

JORGE RAUL JORROT directs the Centro de Estudios de Opinión Pública at the Universidad de Buenos Aires. His major research interests include electoral studies and public-opinion polls as well as social stratification and occupational mobility. He is about to publish a book on social stratification and mobility, based on a large comparative survey carried out in the metropolitan area of Buenos Aires.

ELIZABETH UMLAS serves as Associate Program Officer (Environment) in the Office of the UN High Commissioner for Refugees (UNHCR) in Geneva, Switzerland. She is presently managing a large-scale UNHCR project entitled "Toward Sustainable Environmental Management Practices in Refugee-Affected Areas." She recently completed a Ph.D. in political science from Yale University.

DAVID FELIX is Professor of Economics Emeritus, Washington University in St. Louis. He has written extensively on Latin American development issues and recently has been researching the political economy of financial globalization and its discontents.

PETE BROWN is Assistant Professor of Anthropology at the University of Wisconsin Oshkosh. He recently published articles on the consequences of agrarian reform in rural Mexico, class and ethnic identity in highland Chiapas, and the Zapatistas. He is currently working on a book-length manuscript on the creation of community in highland Chiapas.

EDUARDO SILVA is Associate Professor of Political Science and a Fellow of the Center for International Studies at the University of Missouri, St. Louis. He has pub-

lished several articles on environment and development as well as The State and Capital in Chile: Business Elites, Technocrats, and Market Economics.

ALFONSO W. QUIROZ is Professor of History at Baruch College and Graduate School, City University of New York, and the author of several studies on colonial and modern Peru and Cuba. He also curated two centennial exhibitions on the Spanish-Cuban-American conflict at the New York Public Library and the New York Historical Society. He is currently writing a book on the Cuban question in the nineteenth century.

J. MARK RUHL is Glenn and Mary Todd Professor of Political Science at Dickinson College. He has written extensively on the role of the military in Honduras and Colombia and on a range of other topics concerning Latin American politics.
