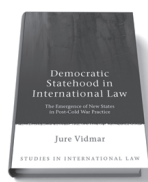
Democratic Statehood in International Law

The Emergence of New States in Post-Cold War Practice

Jure Vidmar

This book analyses the emerging practice in the post-Cold War era of the creation of a democratic political system along with the creation of new states. The existing literature either tends to conflate self-determination and democracy or dismisses the legal relevance of the emerging practice on the basis that democracy is not a statehood criterion. Such arguments are simplistic. This book demonstrates that via the right of self-determination the law of statehood requires for state creation to be a democratic process, but that this requirement should not be interpreted too broadly. The democratic process in this context governs independence referenda and does not interfere with the choice of a political system.

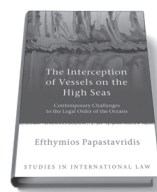
The Interception of Vessels on the High Seas

Contemporary Challenges to the Legal Order of the Oceans

Efthymios Papastavridis

The aim of this book is to address the international legal questions arising from the 'right of visit on the high seas' in the 21st century. It begins with an historical and theoretical examination of the framework underlying interception. This historical survey informs the remainder of the work, which then looks at the legal framework of the right of visit, contemporary challenges to the traditional right, interference on the high seas for the maintenance of international peace and security, interferences to maintain the 'bon usage' of the oceans (navigation and fishing), piracy *jure gentium* and current counter-piracy operations off the coast of Somalia, the problems posed by illegal, unregulated and unreported fishing, interdiction operations to counter drug and people trafficking, and recent interception operations in the Mediterranean Sea organised by FRONTEX.

The Proposed Nordic Saami Convention

National and International Dimensions of Indigenous Property Rights

Edited by Nigel Bankes and Timo Koivurova

In 2005 an expert group representing the governments of Norway, Sweden and Finland, and the Saami parliaments of these countries agreed upon a draft text of a Nordic Saami Convention. Key parts of the text deal with the recognition of Saami land and resource rights. More recently the three governments have embarked on negotiations to move from this draft text to a final convention that may be adopted and ratified by all three countries. Negotiations commenced in the Spring of 2011 and should be completed within five years. This collection of essays explores the national and international dimensions of indigenous property rights and the draft Convention which recognises the Saami as one people divided by international boundaries.

Over the last two years, Professor **Laurie Blank** has published nearly a **dozen scholarly articles**, a manual on law of war training for military and civilian leaders, and a steady flow of major media op-eds. In the coming months, she will add to this impressive record a further co-authored volume, *International Law and Armed Conflict: Fundamental Principles and Contemporary Challenges in the Law of War*.

This would be a striking record for anyone. In Blank's case, it comes on top of her leadership of Emory Law's **International Humanitarian Law Clinic**. Through the Clinic, Blank and her students have assisted dozens of organizations, from the U.S. Marine Corps to the Special Court for Sierra Leone, working to enhance compliance with the law of war and minimize the devastating consequences of war for humanity.

On March 22, 2011, New York Federal District Court Judge Denny Chin rejected a proposed settlement in two lawsuits against Google. The settlement would have allowed Google to continue scanning copyrighted books into its search index and displaying the text to its users in exchange for the payment of license fees to copyright holders.

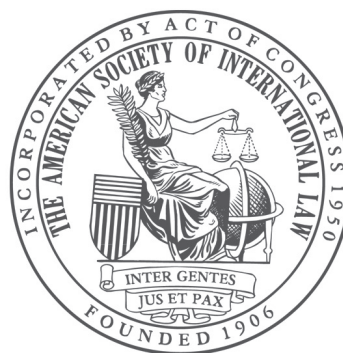

International Law in a Multipolar World

While the United States is arguably still the only superpower and the European Union remains the largest economy, the world is undergoing major change. China, India, Russia, Brazil, and other States in Asia, Latin America, the Middle East, and Africa are increasingly active voices in international institutions. These actors are seeking to reshape international rules governing trade and finance, military force, the environment, and beyond.

How will the international legal order evolve to reflect this new multipolar world? Will the international legal order undergo significant change as the global balance of power and influence shifts? Are there barriers preventing these actors from having a full voice in the international legal order? Can the major international organizations adapt adequately? Will new organizations emerge?
