This work, which owes its origin to the initiative of the late Professor Harold Temperley, was planned in 1936. It was designed to trace from the earliest times the antecedents of a nation which had been lately restored to liberty, and the narrative was approaching completion when the events of 1939 put an end suddenly to all communication with Poland. The latter part of the book suffered less than the earlier from this interruption, and, as a fairly comprehensive study of the decline, the servitude, and the rebirth of Poland, it now receives separate publication.
