CONTRIBUTORS

David Catalunya is a researcher at the University of Würzburg as well as a harpsichordist and musical director specializing in late medieval polyphonic repertoires. As musical director of the group *Canto Coronato* and collaborator with others, including *Tasto Sol* and *Mala Punica*, he has received such major awards as First Prize at the Antwerp Festival 2006 and the *Diapason d'or de l'année* 2007. His main research interests are the study of manuscript transmission of late medieval polyphony and the development of historical music analysis methods.

Carmen Julia Gutiérrez is Professor of Musicology at the Universidad Complutense de Madrid and a specialist in Spanish and European medieval music involved in the making of critical editions, the cataloging, retrieval and editing of sources, the study of composition processes, and the transmission and reception of medieval music. She is the director of the research project *El canto llano en la época de la polifonía*, which aims (in collaboration with DIAMM) to reclaim and visually restore medieval Spanish polyphonic sources.

Stefano Mengozzi is Associate Professor of Music at the University of Michigan, Ann Arbor. The present article is the latest of a number of publications on the subject of hexachordal theory and practice in the Medieval and Renaissance eras.

Alejandro Enrique Planchart is Professor Emeritus of Music at the University of California. He has published extensively in the fields of Latin plainsong and the music of the fifteenth century.
