Plato's Universe

SENTIENCE

Wallace I. Matson

Professor Matson's newest work sets itself an interesting task: "Man need not be degraded to a machine by being denied to be a ghost in a machine", Gilbert Ryle has said. "He might, after all, be a sort of animal, namely, a higher mammal. There has yet to be ventured the hazardous leap to the hypothesis that perhaps he is a man."

Wallace Matson has made the venture. Even though he finds no valid objection to the conception of mind as nothing over and above functioning of the nervous system, he argues that nevertheless no existing or imagined machine models the nature of that function. *Sentience* is not just reception of information; it is what he calls "sizing up"—picking out of a situation those features that are more important, apperceiving the whole which they compose, relating this whole to the creature's interest, and deciding what to do about it. Finally he shows how sizing up makes possible free action in the positive sense of action to which conscious deliberation makes a difference.
