A Memoir of My Years in China's Gulag

Bitter Winds by Harry Wu and Carolyn Wakeman is a deeply moving memoir - the story of one man's struggle to survive the Chinese Gulag and his daring return to China to tell the world what happened there

Submission of a manuscript is taken to imply that it has not previously been published in any form (including non-copyrighted working papers) and that it is not currently being considered elsewhere.

Romanization

Pinyin is used without tone/diacritical marks, except the following which should use the Wade-Giles system: names such as Chiang Kai-shek, Sun Yat-sen, Taipei and Kuomintang; names of individuals living outside mainland China. Chinese characters should be provided on the first occurrence of each romanization, to assist in proofreading.
