

# Biographies

*Howard Brunt*, R.N., Ph.D., is an associate professor of nursing at the University of Victoria. His major areas of research include epidemiology and health promotion. Most recently, he has completed research on falls prevention for the elderly and heart disease risk reduction in the Hutterite population of Alberta.

*G. Iain Carpenter*, M.D., F.R.C.P., is Senior Lecturer in Health Care of the Elderly, King's College School of Medicine and Dentistry and the Centre for Health Studies, University of Kent and Consultant Physician at the Kent and Canterbury NHS Trust Hospitals. His research and development activities covered screening the elderly in the community, dependency in sheltered housing and developing an elderly casemix system for the National Casemix Office. His current work is focussing on the development of methods for evaluating quality and outcome of elderly care services based on the routine use of standardized assessment in community, nursing home and hospital settings. He is Secretary of interRAI, an international organization developing cross national studies of health care of the elderly.

*Neena L. Chappell*, Ph.D., is a professor of sociology and Director of the research Centre on Aging at the University of Victoria. Her major areas of research include health care, informal care, and quality of life among seniors.

*Ann E. Clarke* is a faculty member in the Centre for the Analysis of Cost-Effective Care and the Divisions of Clinical Epidemiology and Clinical Immunology & Allergy at The Montreal General Hospital. She is also an Assistant Professor in the Department of Medicine at McGill University. Dr. Clarke received her M.D. at the Memorial University of Newfoundland, underwent training in Internal Medicine and Clinical Immunology & Allergy at McGill University, and completed a Post Doctoral Fellowship at Stanford University in Health Services Research. She currently holds a Junior Clinician Scholars Award from the Fonds de la recherche en santé du Québec. Her research interests include assessing the financial and quality of life effects of chronic rheumatic and respiratory illnesses and developing psychoeducational interventions to lessen this burden.

*Philippa J. Clarke* is a doctoral student in the Department of Community Health, University of Toronto. Her research interests are in stroke, chronic illness, and work, in relation to aging.

*Ingrid Arnet Connidis* is a professor in the Department of Sociology and Director of the Interdisciplinary Group on Aging at the University of Western Ontario. She is the author of *Family Ties and Aging* (Harcourt

Brace). Her recent writing and current research have focussed on adult sibling ties and the unique situations of single (never married) and childless older persons.

*Joan Dawe*, is Deputy Minister, Department of Social Services, Government of Newfoundland and Labrador. She served as Assistant Deputy Minister, Community Health, Department of Health, Government of Newfoundland and Labrador, 1991 to 1996. She has held positions in nursing service, nursing administration, hospital administration and regional health planning. She is past president of the Newfoundland Hospital and Nursing Home Association; Newfoundland Association of Health Service Executives and Eastern Newfoundland Chapter of Canadian College of Health Service Executives; and was chairperson of the St. John's Home Care Program; Council for Nursing Assistants, Newfoundland and Labrador; and the Advisory Committee on Nursing Workforce. She was a member of the Board of Directors of the Canadian Hospital Association, the Canadian Centre for Occupational Health and Safety and the Institute for Health Care Facilities of the Future. She currently lectures in the Division of Community Medicine, School of Medicine, Memorial University of Newfoundland.

*Robert G. Evans* is a professor of economics and faculty member of the Centre for Health Services and Policy Research at the University of British Columbia, a national health scientist, a fellow of the Canadian Institute for Advanced Research, and Director of the Institute's Program in Population Health. He is an honorary life member of the Canadian Health Economics Research Association and of the Canadian College of Health Services Executives. He is also a member of the United States National Academy of Social Insurance and of the Prime Minister's National Forum on Health, and previously a member of the British Columbia Royal Commission on Health Care and Costs.

*Janet E. Fast* is an associate professor in the Department of Human Ecology at the University of Alberta. As a consumer and family economist her major research interests relate to the paid and unpaid work of family members. Her recent collaboration with gerontologists involves investigation of the economic consequences of assuming informal caregiving roles.

*Ellen M. Gee*, Ph.D., is a professor and Chair in the Department of Sociology and Anthropology at Simon Fraser University. She is currently involved in two research projects, on Chinese Canadian elders and on life course transitions. She is a past Associate Editor of *Canadian Public Policy* and has served on the executive of the Canadian Association on Gerontology as Social Sciences Division Chair and Chair of the Research Committee.

*Janet Hagey* is currently Director of the Health Statistics Division at Statistics Canada.

*Betty Havens* is a full professor in the Department of Community Health Sciences, Faculty of Medicine, University of Manitoba and a research fellow

with Statistics Canada. She is a research associate of the Manitoba Centre for Health Policy and Evaluation, the Centre on Aging and former Assistant Deputy Minister of Health and Manitoba Provincial Gerontologist. She has served on the National Statistics Council, the Advisory Committees on Health Statistics, which she also chaired, and the National Population Health Survey for Statistics Canada. She currently chairs the Advisory Committee to the Seniors Independence Research Program of Health Canada. She is perhaps best known for her role as the principal investigator of the Aging in Manitoba Longitudinal Studies since 1971. A founding member of the Canadian Association on Gerontology, she served as its President from 1979–1983. She is a fellow of the Gerontological Society of America and has consulted for or held offices in several international health, sociology and gerontology professional, scientific and educational organizations. She also serves in various capacities with the World Health Organization, the Pan American Health Organization and the United Nations.

*John P. Hirdes*, Ph.D., is an associate professor in the Department of Health Sciences and Gerontology, University of Waterloo with a cross-appointment to the Department of Medicine, University of Toronto. He is also Director, Research Department and Canadian Collaborating Centre – interRAI, Providence Centre, Scarborough. His research interests focus on the development and evaluation of assessment systems for long-term care, home care, acute care and psychiatry. As a Fellow of interRAI, he participates in cross-national studies of health care of the elderly with researchers from 16 other countries.

*Jennifer Hopkinson* is the research co-ordinator of the Seniors Drug Focus Project. She obtained her Master's degree in anthropology with a special focus on medical anthropology. Jennifer has considerable research experience, having co-ordinated the Hutterite Heart Health Promotion Project and worked as a research associate on many others.

*Suzanne Inhaber*, B.A., M.P.A., has a Master's degree in Public Policy and Administration. In her current position as Project Officer in the Disease Prevention Division of Health Canada, she is project manager of the Professional Education Strategy of the Canadian Breast Cancer Initiative.

*Norah C. Keating* is a professor in the Department of Human Ecology at the University of Alberta. She is the principal investigator of EPICC, a program of research funded under the Seniors Independence Research Program of Health Canada. The focus of her work is on evaluation of models of continuing care, the interface between the family and the State in eldercare and how families provide care to elderly members.

*Janice M. Keefe* is an assistant professor in the Department of Gerontology, Mount St. Vincent University. She recently completed her Ph.D. in the Department of Family Studies at the University of Guelph. Her research interests are primarily in the area of family caregiving to the elderly

including reciprocity, care by employed women, rural-urban differences and policy development in home care and long-term care.

*Malcolm Maclure*, Ph.D., is Manager of Statistical Analysis and Surveys with the Research and Evaluation Branch of the British Columbia Ministry of Health and adjunct associate professor of epidemiology at Harvard School of Public Health. As principal investigator of the Seniors Drug Focus Project, his aim is to establish an on-going collaboration between researchers inside and outside government for the purpose of promoting evidence-based decision-making.

*Victor W. Marshall* is Director, Institute for Human Development, Life Course and Aging and professor of Behavioural Science, University of Toronto. His current research focusses on work and health, social theories and social policy, all in relation to aging.

*Susan A. McDaniel* is the author of *Canada's Aging Population* (1986), *Family and Friends: General Social Survey Analytical Studies* (1994), and many articles, book chapters and research reports on aging, social policy, gender and families. She frequently advises on policy, specifically as Chair of the Statistics Canada Advisory Committee on Science and Technology, and as an appointed member of the National Statistics Council.

*Lynn McDonald* is a professor and Academic Co-ordinator of the Centre for Applied Social Research, the Faculty of Social Work at the University of Toronto. She is the first author of *Retirement in Canada* and has just finished a report entitled "A Time for Retirement".

*Carol McWilliam* is an associate professor jointly appointed to the Departments of Family Medicine and Nursing at the University of Western Ontario. She is a Career Scientist, sponsored by the Ontario Ministry of Health and the nurse researcher of The Thames Valley Family Practice Research Unit, a multidisciplinary research partnership between the Centre for Studies in Family Medicine and the London Chapter of the College of Family Physicians of Ontario. Her research focusses on health services delivery and health promotion to promote seniors' independence.

*Jennifer Mullett*, Ph.D., is an ecological psychologist whose main interest is social intervention and the concurrent development of theory from the solutions to practical problems. She is the former Director of Research and Evaluation at the Ministry of Health in British Columbia and is currently a lecturer in community psychology at the University of Victoria. As co-investigator on the Seniors Drug Focus Project, she is investigating ways and means of enhancing collaboration in doctor/elderly patient relationships.

*Douglas Norris* is currently Director of the Housing, Family and Social Statistics Division at Statistics Canada and an adjunct research professor at Carleton University.

*Jean Parboosingh*, M.B., Ch.B., M.Sc., graduated from the University of Edinburgh medical school and was a general practitioner in Edinburgh before coming to Canada. She received training in epidemiology, biostatistics and community health at the University of Calgary. In her current position as Senior Medical Consultant in the Disease Prevention Division of Health Canada, she co-chairs the Professional Education Strategy of the Canadian Breast Cancer Initiative.

*Barbara J. Payne*, Ph.D., is an assistant professor in the Department of Sociology and a research affiliate in the Centre on Aging at the University of Manitoba. She also acts as a consultant for the Community Dental Health Services Research Unit in the Faculty of Dentistry, University of Toronto. Her research interests include health and aging with a focus on the social and psychological dimensions of oral health.

*Margaret J. Penning*, Ph.D., is an assistant professor in the Department of Sociology and a research affiliate of the Centre on Aging at the University of Victoria. She is currently principle investigator on "Formal, Informal, and Self Care for Autonomous Living," one of 15 programs of applied research funded through the SIRP, Health Canada. Her research interests include coping with chronic illness and disability, social networks and social support, and service utilization.

*Tanya Potashnik* is a health economist with Pharmacare. She received her Master's degree in economics from the University of Victoria in 1995. Her thesis was "Patent Expiration, Generic Competition and Brand Loyalty in the B.C. Pharmaceutical Industry".

*Evelyn Shapiro*, M.A., is a professor in the Department of Community Health Services, Faculty of Medicine, University of Manitoba and a member of the Manitoba Centre for Health Policy and Evaluation. As a researcher, she is well-known both nationally and internationally for her publications on the elderly and their use of health care. Her other major interest is in the application of research findings to public policy.

*Sylvie Stachenko*, M.D., F.C.F.P., received her medical degree from McGill University. She completed her residency program in family medicine at the University of Montreal and received a Master's degree in Epidemiology and Health Service Administration from the Harvard School of Public Health. She is currently the Director of the Disease Prevention Division at Health Canada. Her section is a focal point in the department for chronic disease prevention strategies and as Director, she has been instrumental in the development and implementation for the Canadian Heart Health Initiative and the National Breast Cancer Initiative. She is also the Canadian Director for the WHO-CINDI international chronic disease prevention program and the director of the WHO Collaborating Centre on policy development in non-communicable disease prevention.

*Robyn Tamblyn* is an epidemiologist who holds an appointment as a medical scientist in the Division of Clinical Epidemiology at the Royal Victoria Hospital and a position of associate professor in the Departments of Medicine and of Epidemiology and Biostatistics at McGill University in Montreal. She is the principal investigator of USAGE (Quebec Research Group on Medication Use in the Elderly) supported by Health Canada and a national research scholar supported by the National Health Research and Development Program.

*Russell Wilkins* is a senior analyst in the Occupational and Environmental Health Research Section of the Health Statistics Division at Statistics Canada in Ottawa. His main research interests are socioeconomic inequalities in health outcomes, and the development and use of health expectancy indicators which take account of both length and quality of life. Prior to coming to Statistics Canada, he worked for the Department of Community Health of the Montreal General Hospital, and at the Institute for Research on Public Policy. His degrees are in anthropology, education and urban planning; he is currently studying epidemiology at the University of North Carolina at Chapel Hill.
