Aims and scope

Byzantine and Modern Greek Studies (BMGS) is an internationally recognized, peer-reviewed journal and one of the leading publications in its field. Published twice a year in spring and autumn, its remit is to facilitate the publication of original research and debate in all areas of Byzantine and Modern Greek studies. The journal welcomes contributions in the form of articles and short notes.

Subscription rates *Byzantine and Modern Greek Studies* (ISSN 0307-0131) is published twice a year in April and October. Two parts form a volume. The subscription price (excluding VAT) of volume 45 (2021), which includes print and online access, is £297 (US\$515 in the USA, Canada and Mexico) for institutions. The electronic-only price available to institutional subscribers is £265 (US\$483 in the USA, Canada and Mexico).

The subscription price for individuals ordering direct from the publisher and certifying that the journal is for their personal use is £79 (US\$150 in the USA, Canada and Mexico), plus a reduced electronic-only price of £65 (US\$121 in the USA, Canada and Mexico).
