

THE REINTERPRETATION OF AMERICAN ECONOMIC HISTORY

In this unique supplementary reader, the basic analytical tools introduced in principles and intermediate theory courses are set forth and applied to concrete aspects of the development of the American economy. A product of the cliometric revolution of the past decade which reunified theory and history, the book will help teachers of undergraduate theory demonstrate the relevance of economic principles to actual events. Articles skillfully apply explicit, simple models to familiar episodes of American history (elementary Keynesian model of national income determination to the New Deal fiscal policies, simple equation for the quantity of money to Jackson's war against the Second Bank, theory of factor pricing, capital, and rent theory to slavery and economic exploitation, and supply and demand analysis to the cotton textile and iron industries). EUROPEAN ECONOMIC HISTORY

Tenth Century to the Present

ELIAS H. TUMA, University of California, Davis

Spanning the period from the emergence of modern Europe to the age of technology, EUROPEAN ECONOMIC HISTORY is a well-documented analysis covering all of Europe, including Russia, Eastern Europe, and the Scandinavian nations. Arranged topically rather than by countries, the book is also a provocative evaluation of the scope, method, and relevance of economic history that integrates new and traditional approaches and incorporates much recent statistical data. Emphasis is on the interrelationship of history and theory and on comparative theories of economic development and decline in various countries, including the influences of demography and technology on economic change. Each section of the book is self-contained and may be used independently of the others in both quarter and semester systems. 384 pages; \$12.95. April 1971.

The author's general introduction emphasizes the historiographical background of the collection; headnotes place each essay in the general context of the book and point to the basic questions. THE GROWTH OF ECONOMIC THOUGHT

Henry W. Spiegel, The Catholic University of America

Why did economic thought take a certain turn at a certain time? Dr. Spiegel avoids the current tendency to convert the economic ideas and proposals of the past into bloodless, mathematical models. He examines this question in *THE GROWTH OF ECONOMIC THOUGHT* in light of the humanities. He begins by studying the lives, the schools, the intellectual and social milieux and the personal thought-worlds of the economists themselves, and thereby explores economic theory within the locus of familiar intellectual and cultural periods. He integrates and focuses the analyses of earlier periods by systematically asking how each economist (or his school) proposed to cope with the fundamental problem of scarcity. Finding special relevance to current economic hang-ups in these periods and in their economic dialectics make them come alive. The author includes a comprehensive, cosmopolitan discussion of Twentieth Century economics. He meticulously documents the current transformation of economics into econometrics—with special attention to the impact of such mathematicians as von Neumann and Wald and to contemporary trends of thought in France.

ECONOMIC DEVELOPMENT OF THE NORTH ATLANTIC COMMUNITY

Dudley Dillard, University of Maryland

ECONOMIC DEVELOPMENT OF THE NORTH ATLANTIC COMMUNITY traces the growth of the European and American economies from medieval origins to the present. The author views the evolution of these two economies as two closely related phases of a common development.

Professor Dillard introduces basic ideas in economic analysis to give a broader insight into the organization and function of the North Atlantic economic system. The text also presents the classical theory of distribution, relating wages, profits and rent, to show the significance of free trade to England's industrial leadership during the nineteenth century.

Professor Dillard employs the macroeconomic theory associated with the English economist John Maynard Keynes to explain the behavior of the North Atlantic economic system as a whole. Keynes' concepts of investment, saving, consumption and aggregate income are particularly relevant, the author notes, in view of the trend of European and American capitalism since the Great Depression.
