# APSA Research Grant Program



The Council of the American Political Science Association announces the 1994 small grant program to support research in all fields of Political Science

### Scope of Award

Projects should address a significant problem in political science. Proposals must (1) specify research design; (2) state how the project relates to previous research and theoretical developments; and (3) state how the project contributes to scholarship within a field.

### Eligibility.

Applicants must be APSA members. In addition, the principal investigator must be one of the following:

- (a) a political science faculty member at a college or university that does not award a PhD in political science.
- (b) a political scientist not affiliated with an academic institution.

### **Funding**

Grants will be awarded annually by the Committee on Research Support. The Council has made \$15,000 available for 1994 research grants. Individual grants will not exceed \$1,500 and are not renewable.

Funds may be used for such research activities as: travel to archives; travel to conduct interviews; administration and coding of survey instruments; and purchase of data sets. This list is merely illustrative, but specifically excluded from funding are: travel to professional meetings; secretarial costs except for preparation of the final manuscripts for publication; and salary support for the principal investigator.

### Format.

Proposals should be no more than five pages (single-spaced) with a title page listing: name, title of project, current affiliation, and amount requested. Proposals must have a budget, budget justification, and curriculum vitae attached. Proposals must address all items under the scope of award and indicate the precise purpose for which the requested funds will be used. Any financial support the principal investigator is already receiving or anticipates receiving should be specified in the proposal.

Eight (8) copies of the proposal with accompanying budget and curriculum vitae should be submitted to:
