WHAT IS IT?

The University Center for International Studies, University of Pittsburgh, in conjunction with the American Political Science Assn., has created an annual reference publication designed especially for scholars and educators doing research in the social and policy sciences. *United States Political Science Documents* (USPSD) is a quality reference tool to assist in your search for appropriate literature among the ever-increasing pool of source materials pertaining to your special area of interest. USPSD contains abstracts of articles published in 124 selected U.S. journals as well as a set of five indexes to these documents and a "Rotated Subject Descriptor Display."

USE OF THE INDEXES

USPSD is published in two separate parts. The first part contains the indexes and the second part the document descriptions. Each entry in the indexes supplies the name(s) of an article's author(s), its title, and its complete journal citation. Each entry also supplies a document accession number through which the full description of a document can be found in the second part, where the document descriptions are listed in ascending sequence by document number.

In USPSD the identification of articles of possible relevance is accomplished by consulting one or all of the five indexes: Author/Contributor Index, Subject Index, Geographic Area Index, Proper Name Index, or the Journal Index. A reader of USPSD, then, can search for literature written by a specific author, devoted to a specific subject (such as "southeast asia"), discussing a specific organization (such as "department of defense"), or published in a specific journal. Also included to facilitate use of the Subject Index is a Rotated Subject Descriptor Display.

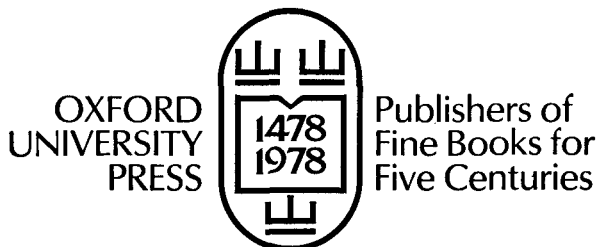
