## **Elite Activism and Political Transformation in China**

Zhejiang Province, 1865-1911

---

**Mary Backus Rankin.** Previous studies of the roots of the 1911 Revolution in China have concentrated on the emergence of new social classes and a provincial activist elite in the decade before the revolution. This book shows that social elites actually began to emerge as a political force much earlier in the aftermath of the Taiping Rebellion. Through a detailed examination of elite groups in the economically advanced coastal province of Zhejiang, the author reevaluates the causes of the 1911 Revolution and also reinterprets the socio-political history of the last half-century of the Qing Dynasty. \$39.50

**Susan Mann.** How did China's stable agrarian society accommodate centuries of dynamic commercial expansion? This study shows how the government policies of High Qing times supported an unprecedented commercial expansion by holding the bureaucracy in check, keeping market taxes low, and farming those taxes to local merchants. The author presents compelling new evidence for a fundamental reassessment of the importance of local merchants and trade organizations in traditional China, and a new perspective from which to explore state intrusions into local society during the 19th and early 20th centuries. \$37.50

Joseph. *Born Red* is an artistically wrought personal account, written from inside the experience, of the years 1966-69, when the author was a teenager at middle school. Gao was caught up in very dramatic events, which he recounts as he understood them at the time—the mass rallies against “capitalist-roader” teachers and administrators, the division of school and town into armed camps, the clash between father and son. **Kang Chao.** A sweeping new interpretation of Chinese economic history emerges from this analysis of two millennia of economic developments in traditional China. Rejecting dynastic, positivist, and Marxian views, the author argues that since 200 B.C. China was a market economy consisting of countless small production units. With limited land for cultivation, freeholders and tenants were forced to adjust their economic choices and decisions in response to an increasing man-land ratio as population pressures mounted through the centuries. Although often labeled the culprit, it was not the unequal distribution of land but the increasing man-land ratio that led to China's impoverishment and technological stagnation. \$35.00
