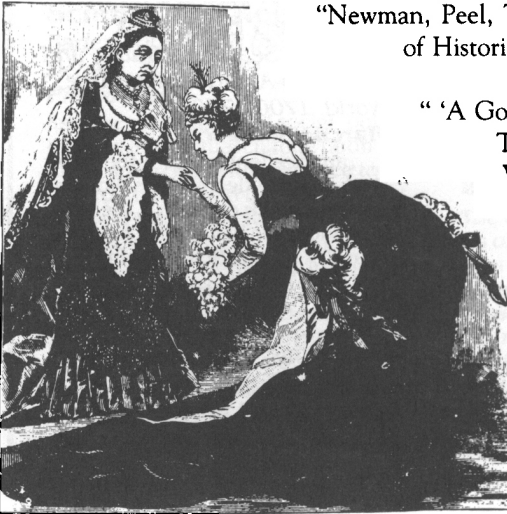

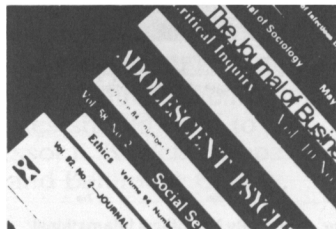

Charles Cashdollar reinterprets nineteenth-century British and American Protestant thought by identifying positivism as the central intellectual issue of the era. Positivism meant, at first, the ideas of the French thinker Auguste Comte; later in the century, the term indicated a more general opposition to supernatural religion. Cashdollar shows that contemporary thinkers recognized positivism, at each of these stages, as the most fundamental of the proliferating challenges to religious belief. He further reveals how the encounter with positivism altered Protestant orthodoxy—in both subtle and radical ways.

The glorification of the monarch as a religious authority is an important feature of the Tudor period (1485–1603), and this study will be essential reading for anyone interested in English Renaissance literature, British history, and art history. Because existing works concentrate on the reigns of Henry VIII or Elizabeth I, this is the first book to survey the evolution of royal iconography throughout the Tudor dynasty. John King shows how the prevailing emphasis on classical rather than religious imagery in studies of Queen Elizabeth in particular has hampered understanding of the importance of scriptural imagery in Tudor royal portraiture, illustration of manuscripts and books, and literature.
