## THE PHILOSOPHY OF SCIENCE ASSOCIATION

The Philosophy of Science Association is an international society dedicated to the furthering of studies and free discussion from diverse standpoints in the field of philosophy of science. To promote these objectives, the Association: holds biennial conferences and arranges for the publication of the proceedings of these conferences; publishes the quarterly journal, Philosophy of Science, which carries essays, discussion articles, and book reviews in the general area of philosophy of science; is an affiliated society of Section L of the American Association for the Advancement of Science; and selects two representatives to serve on the National Academy of Sciences U.S. National Committee for the International Union for the History and Philosophy of Science.

The affairs of the Association are controlled by a Governing Board which is composed of the President of the Association, President-elect, the most recent Past-President, and eight members elected at large.

To supervise the various functions of the Association the Governing Board appoints individuals to serve as Executive Secretary of the Association, Editor-in-Chief of Philosophy of Science, Editor-in-Chief of the PSA Newsletter, and Editor-in-Chief of the PSA Proceedings.

Membership is available to all individuals who agree to the objectives of the Association as stated above and who also agree to reserve their copies of the journal for their personal use only. Prima facie eligibility for full membership, is demonstrated by: 1) holding a Ph.D., D.Sci., or M.D. degree (or equivalent) in philosophy, science or a science related field; or 2) holding a significant scientific research position; or 3) holding the rank of assistant professor (or equivalent or higher rank) at an institution of higher learning in philosophy, science or science related field. To be eligible for associate membership, one must simply be in agreement with the objectives of the Association. To be eligible for student membership, one must be a full-time student at an accredited institution of learning. Payment of annual dues entitles all members to receive the journal, Philosophy of Science at no additional charge. Reduced registration fees are also charged to members for the biennial meetings. Full members are entitled to hold office and vote in the Association's annual election of Governing Board members.

Membership dues are graduated based on income: income below \$40,000 - \$40.00; \$40,000-\$49,999 - \$50.00; \$50,000 or above - \$60.00 for full and associate members. There is a special rate of \$20.00 for student members. Memberships start at the beginning of a calendar year. Members who join during the course of the year will be sent back copies of all material for that year. Contributions to the Association are U.S. tax deductible.

# PHILOSOPHY OF SCIENCE

*Typescript.* Typescript, double-spaced, should be submitted (in triplicate) to Professor Merrilee Salmon, Department of History and Philosophy of Science, University of Pittsburgh, Pittsburgh, Pennsylvania 15260 U.S.A. Typescripts will not be returned unless return postage is prepaid by check, money order, International Postal Reply Coupons or U.S. stamps. A bibliographical list of cited references beginning with the author's last name, initials, followed by the year of publication in parentheses, should be headed 'References' and placed on a separate sheet in alphabetical order. Simple citations should then be made by employing in the text, *rather than by footnote*, the reference list by citing author and year of publication, for example, Jones (1958) or (Smith 1974, 46). A detailed guide to the new reference style appears in the March issue of each year. Discursive footnotes (consecutively numbered) should be kept to an *absolute* minimum. An abstract (also in triplicate) of approximately 100 words must accompany typescript. Typescript must not exceed 9,500 words, including abstract, footnotes and references. A word count must be submitted with each essay. Longer essays will be returned (at the author's expense) to be cut to the acceptable maximum. All figures must be professionally drawn and lettered. All formulas and equations should be put in such a form as to help minimize the number of printed lines in the journal. In the following examples the form on the right is preferable to that on the left:

$$(1) p = -\frac{dx}{dy} = -\frac{dz}{dt}$$

$$p = -dx/dy = -dz/dt$$

$$(2) \frac{1}{x} \prod_{n=1}^{\infty} \frac{\left(1 + \frac{1}{a_n}\right)}{\left(1 - \frac{1}{b_n}\right)}$$

$$(1/x) \prod_{n=1}^{\infty} [(1 + 1/a_n)/(1 - 1/b_n)]$$

*Processing fee.* There is a fifteen dollar per submission processing fee for individuals who are not members of the Philosophy of Science Association.

*Copyright.* Manuscripts should be submitted to *Philosophy of Science* with the understanding that upon publication copyright will be transferred to the Philosophy of Science Association.

*Reprints.* Contributors of articles to this journal will receive, gratis, 25 reprints. Authors desiring additional reprints may order them by sending in, with their corrected galleys, the order forms that they will find enclosed with their galleys.

*Reviews.* Publications intended for review should be sent to Professor Merrilee Salmon, at the address given above.

*Philosophy of Science* is published quarterly; issues are dated *March, June, September* and *December* of each year. Correspondence concerning business matters should be addressed to Peter D.
