Chandran Kukathas is Senior Lecturer in Politics at University College of the University of New South Wales. He is the author of *Hayek and Modern Liberalism* (1989) and coauthor of *Rawls: A Theory of Justice and Its Critics* (with Philip Pettit, 1990). He is coeditor of the recently founded *Journal of Political Philosophy*.

Alan Gewirth is E. C. Waller Distinguished Service Professor of Philosophy at the University of Chicago. He is a fellow of the American Academy of Arts and Sciences and a past president of the American Philosophical Association and the American Society for Political and Legal Philosophy. He has held two Rockefeller Foundation fellowships, two National Endowment for the Humanities fellowships, and a Guggenheim fellowship. His books include *Marsilius of Padua and Medieval Political Philosophy* (1951), *Reason and Morality* (1978), and *Human Rights: Essays on Justification and Applications* (1982). He is currently working on a sequel to *Reason and Morality* titled *The Community of Rights*.

John Kekes is Professor of Philosophy and Public Policy at the State University of New York at Albany. He is the author of *A Justification of Rationality* (1976), *The Nature of Philosophy* (1980), *The Examined Life* (1988), *Moral Tradition and Individuality* (1989), *Facing Evil* (1990), and *The Morality of Pluralism* (1993).

Charles Larmore is Professor of Philosophy and Chairman of the Philosophy Department at Columbia University. He is the author of *Patterns of Moral Complexity* (1987) and *Modernité et morale* (1993), and an editor of the *Journal of Philosophy*. In addition to his work in political theory and in seventeenth-century philosophy (focusing on skepticism), he is now engaged in writing a book on the philosophical contributions of Romanticism.

Nicholas L. Sturgeon is Professor of Philosophy and currently Chair of the Sage School of Philosophy at Cornell University. He has published a number of articles on moral realism and on related metaphysical and epistemological issues in ethics. He is also interested in the history of British moral philosophy in the seventeenth and eighteenth centuries, and has written on Butler and on Hume.

Ernest Sosa is Romeo Elton Professor in the Philosophy Department of Brown University. He has been editor of *Philosophy and Phenomenological*

Research since 1983 and of *Cambridge Studies in Philosophy* since 1990. He has published papers in epistemology and metaphysics and is author of the collection *Knowledge and Perspective* (1991).

Joseph Raz is Professor of the Philosophy of Law at Oxford University and Fellow of Balliol College, Oxford. He is a fellow of the British Academy and an honorary foreign member of the American Academy of Arts and Sciences. His books include *The Authority of Law* (1979), *The Concept of a Legal System* (1980), *The Morality of Freedom* (1986), and *Practical Reason and Norms* (1990).

Wallace I. Matson is Professor of Philosophy, Emeritus, at the University of California, Berkeley. He has written books and articles on the history of philosophy, philosophy of mind, philosophy of religion, Spinoza, and social philosophy.

David O. Brink is Associate Professor of Philosophy at the Massachusetts Institute of Technology. His research interests are in ethical theory, history of ethics, political philosophy, and legal theory. He is the author of *Moral Realism and the Foundation of Ethics* (1989).

Geoffrey Sayre-McCord is Associate Professor of Philosophy at the University of North Carolina at Chapel Hill. A coeditor of the journal *Noûs*, he has written on a number of topics related to moral realism, contractarian moral theory, and the history of ethics. His edited collection *Essays on Moral Realism* was published in 1988.

Gilbert Harman is Professor of Philosophy at Princeton University, where he has taught since 1963. He is the author of *Thought* (1973), *The Nature of Morality: An Introduction to Ethics* (1977), *Change in View: Principles of Reasoning* (1986), and numerous articles. He serves on the editorial boards of several journals, including *Behavioral and Brain Sciences*, *Philosophy and Phenomenological Research*, and *Social Philosophy & Policy*. He is co-director (with George Miller) of the Princeton University Cognitive Science Laboratory and is head of Princeton's Undergraduate Program in Cognitive Studies. His current research interests include explaining why people value what they value, moral objectivity, the nature of consciousness, the role of practical considerations in scientific reasoning, and the interpretation of probability.

Bernard Boxill is Professor of Philosophy at the University of North Carolina at Chapel Hill. A previous contributor to *Social Philosophy & Policy*, his essays have also appeared in *Philosophy & Public Affairs*, *Ethics*, *Social Theory and Practice*, *Philosophical Forum*, and other journals. A second edition of his book *Blacks and Social Justice* was published in 1992.
