THE CONTRIBUTORS

ROBERT C. TUCKER, formerly an attaché of the American Embassy in Moscow and later a member of the Social Science Division of The RAND Corporation, is now Associate Professor of Government at Indiana University. He is completing a study of the genesis of Marxism that will be published in 1960 by Cambridge University Press.

WOLFGANG J. HELBICH, after study at the Free University in West Berlin, the University of Heidelberg, and the University of Paris, spent two years at Princeton, where he received a B.A. degree in history. He has returned to the Free University to complete his doctoral dissertation, which deals with the reparations question under the Brüning government.

HOWARD R. SWEARER is writing a doctoral dissertation on local government in the USSR for Harvard University under a Ford Foundation fellowship.

HENRY G. AUBREY is Visiting Professor on the Graduate Faculty of the New School for Social Research in New York, and Director of Research in the Project on the Economics of Competitive Coexistence carried on by the National Planning Association in Washington. His publications include *United States Imports and World Trade* (1957).

HERBERT GOLDHAMER is a senior staff member of the Social Science Division of The RAND Corporation. He published *Psychosis and Civilization* with A. M. Marshall in 1953 and is now working on problems of social mobility.

HANS SPEIER is chief of the Social Science Division of The RAND Corporation. His most recent book is *German Rearmament and Atomic War* (1957).

ALLAN EVANS engaged in teaching and research in history before World War II. Since 1942 he has been associated with research aspects of intelligence in OSS and the Department of State, where he is now Special Assistant for Reports and Estimates in the Bureau of Intelligence and Research.

ROBERT WAELDER, a psychoanalyst in Philadelphia, has a long-standing interest in political and historical problems and has published several articles in which such problems are dealt with in psychological terms. A book by him entitled *Basic Theory of Psychoanalysis* will appear in the latter part of 1959.

MYRON WEINER, Assistant Professor of Political Science and Chairman of the Undergraduate Indian Civilization Program at the University of Chicago, is the author of *Party Politics in India* (1957) and a contributor to the forthcoming volume, *The Politics of Underdeveloped Areas*, edited by Gabriel A. Almond and James S. Coleman.

W. PHILLIPS DAVISON has been a member of the Social Science Division of The RAND Corporation since 1948, except for one year as Visiting Professor of Political Science at MIT. He is a former editor of the *Public Opinion Quarterly* and author of *The Berlin Blockade: A Study in Cold War Politics* (1958).

ARTHUR LEE BURNS is a Fellow in International Relations at the Australian National University in Canberra. A contributor to *NATO and American Security* (1959), edited by Klaus Knorr, he is engaged in research on problems of defense and armaments, the structure of international systems, and arms control.

MICHAEL LINDSAY (LORD LINDSAY OF BIRKER) was recently appointed Professor in the School of International Service at the American University in Washington, D.C. He is the author of *China and the Cold War* (1955) and *Is Peaceful Co-existence Possible? (Ho-p'ing Kung-tsun Shih Fo K'e-neng?)*, which will be published shortly in Hong Kong.
