Mark Aldrich is Marilyn Carlson Nelson Professor of Economics at Smith College. He has also served as a senior economist at the Occupational Safety and Health Administration. His most recent work is *Death Rode the Rails* (Johns Hopkins, 2006). His primary teaching and research interests are the economics of the environment and economic history. He is the creator of *Railroad Cartoons* (<http://sophia.smith.edu/~maldrich/>) and *Cartooning Evolution, 1861–1925* (<http://sophia.smith.edu/~maldrich/Evolution/>).

Steven A. Bank is professor of law and vice dean at the UCLA School of Law. His book *From Sword to Shield: The Transformation of the Corporate Income Tax, 1861 to Present* has just been published by Oxford University Press. Other recent publications include “Is Berle and Means a Myth?” *Business History Review* 83 (Autumn 2009) (with Brian R. Cheffins) and *War and Taxes* (2008) (with Kirk Stark and Joe Thorndike).

Brian R. Cheffins is the S. J. Berwin Professor of Corporate Law at the Faculty of Law, University of Cambridge and a fellow of the European Corporate Governance Institute. *The History of Modern U.S. Corporate Governance*, a sourcebook he has edited, will be published by Edward Elgar in 2011.

Juliette Levy is assistant professor of history at the University of California, Riverside. The focus of her work is the role of intermediaries in formal markets in Latin America. Among her recent publications are “The Marriage Penalty: Women, Property Rights and Credit Markets in Yucatan, 1850–1900,” which appeared in the *Hispanic American Historical Review* (August 2008). She is completing her first book, “Credit without Banks: Financial Intermediaries and Personal Networks in Yucatan, 1850–1900.”

Joachim Lund is associate professor at the International Center for Business and Politics, Copenhagen Business School. He has published extensively on the political and economic history of Denmark during the German occupation. His most recent book in English is *Return to Normalcy or a New Beginning? Expectations and Concepts for a Post-war Europe* (edited with Per Øhrgaard, 2008).

Javier Silvestre is associate professor at the University of Zaragoza, Spain. His research in the field of workplace safety has been published in *Labor History* and *Social History of Medicine*. He is the coeditor of a forthcoming book (in Spanish) on the origins of the welfare state in Spain (1900–1945).
