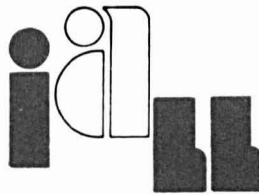

Law and Economics of International Telecommunications

The traditional system of international telecommunications is undergoing fundamental changes caused by new technologies and new public policies on the national and international levels. The legal and economic issues underlying this process of privatization, deregulation and re-regulation are the subject of studies undertaken at the Max Planck Institute in Hamburg, in cooperation with scholars from America, Asia and Europe. The series »Law and Economics of International Telecommunications« is dedicated to the publication of these studies. Comprising reports from representative countries that analyse the interface of national and international telecommunications systems, it deals with point-to-point communications, broadcasting and the »new media«. Further studies will deal with key policy issues including the protection of privacy and the role of international organizations, particularly the European Economic Communities, the International Telecommunication Union (ITU) and the International Telecommunications Satellite Organization (INTELSAT).

Das Völkerrecht ist lebendiges Recht, es lebt im Verkehr der Staaten untereinander. Seine Geschichte ist daher immer zugleich eine Geschichte eines Staatensystems. So ist Völkerrechtsgeschichte alles andere als ein Gegenstand engen, juristisch-fachwissenschaftlichen Interesses. Sie ist vielmehr intensiv verweben mit der allgemeinen politischen Geschichte, so daß sich immer wieder Historiker mit ihr beschäftigen – ebenso wie Diplomaten, Politiker, Journalisten – sie alle meist aus einem konkreten Anlaß der Zeitgeschichte.

Gleichwohl fehlt es an einer wissenschaftlichen Aufbereitung des einschlägigen Quellenmaterials. Anfang der zwanziger Jahre erschien zum letzten Mal eine völkerrechtsgeschichtliche Quellensammlung: Das inzwischen längst vergriffene, kaum noch zugängliche und heutigen Ansprüchen wohl auch kaum noch genügende vierbändige Werk «Documents pour servir à l'histoire du droit des gens» (Berlin, 1923), von Karl Strupp, eine erweiterte Auflage seines 1911 publizierten zweibändigen Werkes „Urkunden zur Geschichte des Völkerrechts“.

Neuere Quellensammlungen beschränken sich stets auf das heute geltende Völkerrecht und verzichten auf historische Dokumente. Die hier erkannte Lücke will das angezeigte Werk schließen. Es ist angelegt auf drei Bände, welche die gesamte Entwicklung von der Antike bis zum Ende des zweiten Weltkrieges umspannen. Der zuerst vorgelegte Band erfaßt den mittleren Zeitraum vom Ende des 15. Jahrhunderts bis zum Wiener Kongreß (Band 3 wird die Zeit von 1815 – 1945 umfassen, Band 1: Von den Anfängen bis 1493).

Bei den abgedruckten Texten handelt es sich um Verträge (Friedens-, Handelsverträge usw.), Deklarationen (Kriegs-, Neutralitätserklärungen), Gesetze, (Neutralitäts-, Ausländer-, Enteignungsgesetze usw.), Satzungen (Privilegien der großen Handelskompanien), Schifffahrtspapiere (Kaperbriefe, Geleitscheine usw.) – d. h. alle Arten von Schriftzeugnissen der völkerrechtsgeschichtlichen Entwicklung.

Da wissenschaftlichen Anforderungen nur ein Quellenwerk genügen kann, das in allen Fällen den authentischen Originaltext wiedergibt, ist dieser jeweils – meist als Reproduktion eines Originals – zuerst abgedruckt.

Diesem Ur-Text wird jeweils eine deutsche und eine englische Übersetzung (oder mindestens eine Inhaltsangabe) synoptisch gegenübergestellt. Vergleiche der verschiedenen Sprachfassungen sind auf diese Weise mühelos möglich. Zahlreiche Zwischenüberschriften über einzelnen Artikeln oder Abschnitten erschließen den Stoff und erleichtern die rasche Orientierung. Die unübersichtbare Menge des Stoffes nötig natürlich zur Auswahl und zwar sowohl im Hinblick auf die Aufnahme eines Dokumentes als auch seiner Teile (Artikel, Absätze usw.).

Solche Auswahl setzt eine Beherrschung des Stoffes voraus. Sie ist durch Professor Grewe gewährleistet, der sich mit vielen Publikationen, insbesondere mit seinem soeben in 2. Auflage erschienenen, allgemein anerkannten Werk „Epochen der Völkerrechtsgeschichte“ als berufener Herausgeber eines solchen Quellenwerkes ausgewiesen hat. Die „Epochen der Völkerrechtsgeschichte“ bilden das theoretische Fundament, auf dem das hier angezeigte Quellenwerk aufbaut: Epochengliederung und Gruppierung der Institutionen und Sachfragen entsprechen diesem für seine Konzeption maßgeblichen Grundlagenwerk.

Der Titel «Fontes Historiae Juris Gentium» ist in Anlehnung an das Quellenwerk «Fontes Juris Gentium» gewählt worden, das in den dreißiger Jahren von Viktor Bruns, dem Direktor des Kaiser-Wilhelm-Instituts für ausländisches öffentliches Recht und Völkerrecht in Berlin, herausgegeben wurde. Von diesem unterscheidet sich das hier angezeigte Quellenwerk durch seine historische Perspektive, die dem älteren Werke fehlt.
