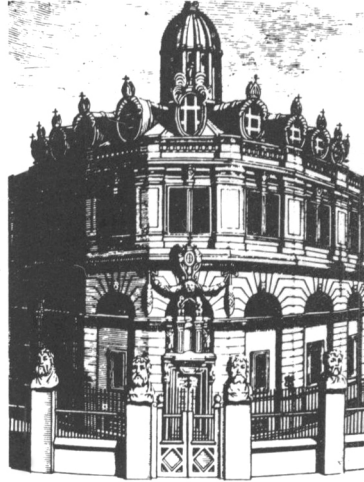

Reformation and Revolution 1558-1660

ROBERT ASHTON, *University of East Anglia*. This work skillfully encompasses one of the most dramatic periods in English history — the century from the accession of Elizabeth I to the Restoration. Ashton explains the causes and plots the progress of the Civil War, the rise of Cromwell, the execution of the king in 1649, and the establishment of the Commonwealth, and covers the colonization of Ulster, the settlements in Virginia and New England, Cromwell's crushing of the Catholics in Ireland, and the chaos into which the country was plunged after his death.

A History of the Church of England, 1945-80

PAUL A. WELSBY, *Rochester Cathedral*. The three archbishops, Geoffrey Fisher, Michael Ramsey, and Donald Coggan, who led the Church of England through the years covered by this book, were men of widely different characters and gifts, and their leadership has often been reflected in the concerns of the Church. Welsby recounts the events of canon law reform and the reorganization of city and country parish life after the war, as well as the more sensational moral and theological problems of recent years.

Hensley Henson

OWEN CHADWICK, *University of Cambridge*. Herbert Hensley Henson strenuously defended the establishment of the Church of England, and then, because the House of Commons behaved badly over the Prayer Book, became its most vocal assailant. In addition to presenting a thoughtful portrayal of Henson, Chadwick provides a study of Church and Society between the two World Wars as seen through the eyes of a caustic, individualist churchman.

The Impact of Industrialization upon Oxford, 1918-1939

R.C. WHITING, *University of Leeds*. Between the wars, the development of Morris Motors and the Pressed Steel plant at Cowley transformed Oxford from an inward-looking town based on the University to an industrial center of national economic importance. Whiting's original study of this transition assesses change and continuity in patterns of employment, industrial relations, and local politics, and analyzes the nature and performance of the Labour Party, trade unions, and the Communists outside their traditional strongholds.

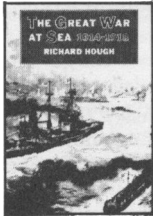

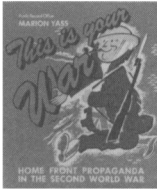
Two three-week sessions are scheduled July 8-28 and July 29-August 18, 1984.
