ERIC BELLQUIST Honored

Eric Bellquist, who became professor emeritus in June after thirty-six years on the Berkeley political science faculty was named a Knight Commander of the Royal Order of the Northern Star of Sweden for his "extraordinary services rendered" in promoting relations between Sweden and the United States and in recognition of his scholarly work on Scandinavian political affairs for over forty-five years. The award, the second highest national honor which has only rarely been given to non-Swedish citizens was bestowed on Professor Bellquist by King Gustaf Adolf IV's granddaughter, Princess Christina, at the Swedish Information Services Office in San Francisco.

VINSON Papers

Supreme Court, 1946-1953. The collection, numbering over 300,000 items, covers the years 1907 to 1953 and includes general correspondence, subject files, motion pictures, recordings, and memorabilia sections.

IRS Ruling

The Internal Revenue Service has issued a ruling concerning participation in politics by students at educational institutions. In ruling 72-513, IRS said a university was not considered to be participating in a political campaign by offering a political science course which requires students to participate in political campaigns. IRS said it found that the course being offered was exclusively educational in nature since it was provided as part of a political science program to improve and develop the students' knowledge and skills.

Northwestern **EVALUATION** **Research Program**

A summer fellowship program at Northwestern University in evaluation research for Ph.D.-level social scientists and policy planners with a good quantitative background and an active research role with an action agency or project has recently been announced. The program consists of two annual summer sessions of eight weeks each on the Northwestern University campus with an intervening year of supervised, on-the-job research. The first summer will cover research design, measurement, and evaluation statistics; the second will deal with analysis of research data and related special topics. Fellowship stipends are available. MATHEMATICAL **Models in Political Science**

Virginia Polytechnic Institute and State University will conduct a short course in Mathematical Models in Political Science, June 11 through July 6, 1973. The short course, supported by the

National Science Foundation, will acquaint participants with the value and limitations of model building in political science. Each participant will be expected to construct and present at least one model within his field of scholarly competence.

Participation in the course is limited to Ph.D.'s (or M.A.'s with special credentials) teaching political science at the college level. Though a high level of mathematical sophistication is not required for participation in the short course, preference will be given to those applicants with the greater degree of education, experience, or practice in mathematics, statistics, logic and related fields.

USIA

Volunteer Speakers

The Speakers Services of the U. S. Information Agency (USIA) is intensifying its recruitment of APSA members who would be willing, while traveling abroad on other than Government grants, to lecture under U.S. Embassy or USIA auspices on a volunteer basis.

Should programming opportunities arise, speakers may be asked to speak before professional groups, participate in seminars or panel discussions, lecture at universities, or attend social events offering opportunities for the informal exchange of ideas with colleagues in the same field.

USIA's Speakers Services office in Washington compiles and transmits to its overseas posts information regarding the availability of scholars and specialists who are willing to serve. It cannot make travel grants or programming commitments but USIA's posts needing the services of a speaker usually offer them a modest honorarium per appearance, per diem and travel expenses for any detours from their planned itinerary. Such posts will contact the specialist direct either at his U.S. address or at given addresses overseas to arrange speaking commitments and compensation.

The greatest benefit to APSA members results from the Embassies' advance planning and preparations for meetings with colleagues and others concerned with their own fields of interest. Embassy sponsorship of a speaker also often opens doors which might otherwise take more time than a APSA member has at his disposal.

Even so, for effective programming, volunteers should plan to spend more than a workday or two in any city where they wish to lecture. Members planning to spend a sabbatical abroad or travel within the next six months privately or under sponsorship other than a U.S. Government grant should send the information requested in the following form to USIA, Information Center Service, Speakers Services Office, Washington, D.
