## FOREWORD

THE society is indebted to the following members who, in addition to the Editorial Board, have read some of the material here published: Charles G. Nauert, Eugene F. Rice, Jr., Marvin L. Trachtenberg.

A general statement regarding the editorial policy of the Board will be found in the Foreword to volume IV (1957) and in the minutes of the annual meeting of the Council. Briefly, the Board favors 'studies which do not fall wholly within the scope of other scholarly journals, particularly the philological journals'. Of particular interest are studies which clearly relate two areas of Renaissance culture.
