It is the editorial policy of Series B to encourage the publication of papers concerned with novel applications of mathematics in real situations or mathematics which is likely to interest a wide audience among applied mathematicians. In this context *Applied Mathematics* is to be interpreted broadly but with the exception of material essentially statistical in nature.

It is intended to minimize publication delays and for this purpose it may prove necessary to reject manuscripts solely on the ground of lack of available space.
