## NSF Social Science Division Position Opening

---

The current Director of the Division of Social Sciences at the National Science Foundation, Dr. Herbert L. Costner, has announced that he will be leaving that position in the fall of 1979. The Directorate for Biological, Behavioral and Social Sciences is now seeking candidates for his replacement, to serve a two-year term. The Division includes programs in Economics, Geography and Regional Science, Political Science, Sociology, Law and Social Science, Measurement Methods and Data Resources, and History and Philosophy of Science.

The Division Director is responsible for administering programs of basic research grant support, planning and budgeting, representing the social sciences in the Foundation, and providing leadership for the NSF social science effort. Appropriate candidates would have a broad knowledge of the social sciences, experience in basic research, and administrative skill. The position is excepted from competitive civil service and equivalent to GS-16 or -17, with a salary ranging from \$42,423 to \$47,500.
