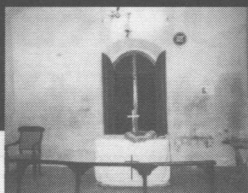

“This is an important book for three reasons. First, it provides a wealth of detail about a fascinating encounter between the Christian message and an ancient multireligious culture. Second, it focuses on Christians embedded in South Indian society instead of on Western missionaries, vividly portraying the Lutheran Pietist community as a church united in its scriptures, doctrines, festivals, and liturgy incorporating caste groups of different rank who ‘sat together separately.’ Third, Dennis Hudson makes credible that church’s pluralistic approach to Christian unity to readers more familiar with later missionaries’ attempts to force equality. This story is only one chapter in a long Christian history, but it is one that modern Christians need to ponder as we seek to understand an earlier hierarchical model of unity, even if we do not accept it, especially since our own theology of equality has often meant in practice that we exclude others from our community. This volume is an outstanding example of historical imagination and empathetic understanding.”

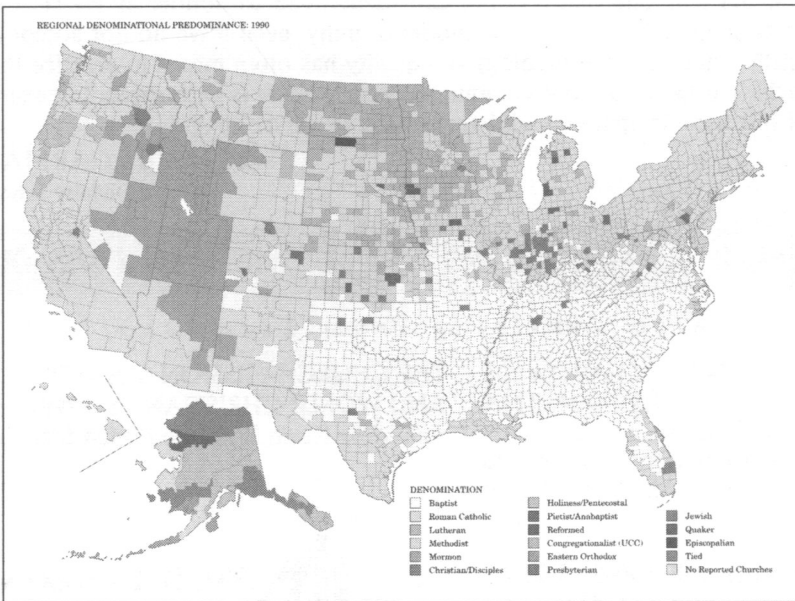

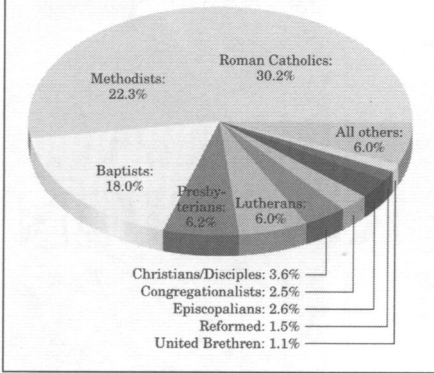

THE UNITED STATES: 1890

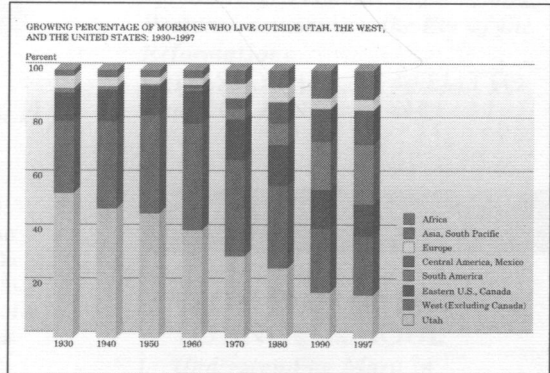

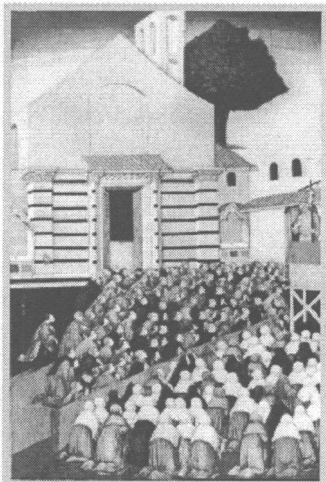

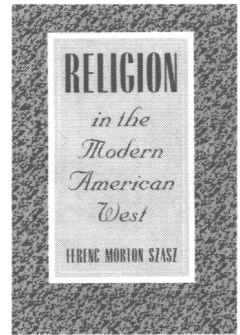

In this first historical overview of religion in the modern American West, Ferenc Szasz traces the major faiths from the late-nineteenth to late-twentieth century, analyzes their distinctive responses to national events, and shows how western cities became homes to a variety of organized faiths that cast only faint shadows back east.

Szasz shows how religion lies at the very heart of the western experience: churches and synagogues shaping their local communities through schools and hospitals; the Latter-day Saints making innovations in social welfare during the Great Depression; Pentecostal groups carrying their traditions to the Pacific coast. He then tells how Asian faiths, revitalized evangelical Protestantism, post-Vatican II Catholicism, Native American spirituality, and New Age sects combined to make western cities among the most religiously pluralistic in the world.

Religion in the Modern American West weaves the story of religion into a wider social and cultural context and broadens our understanding of the American experience.

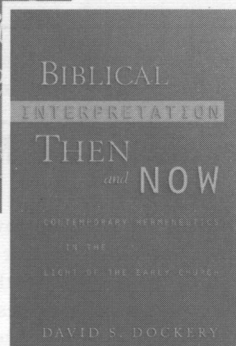
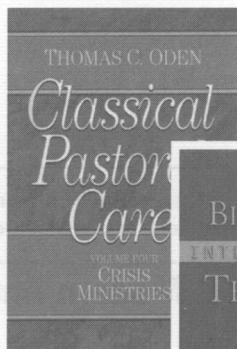
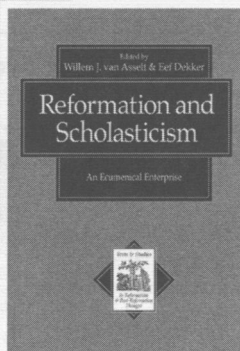
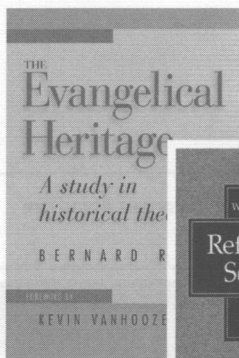

Awards of the American Society of Church History:

The Frank S. and Elizabeth D. Brewer Prize, offered annually, is a subvention fund of \$1,000 to assist a press in publishing a book-length manuscript in church history. The prize is limited to first books. The monetary grant will be made upon receipt of a commitment in writing from a publisher accepting the manuscript. Entries in their final form must be received by 1 November.

The Albert C. Outler Prize is an award in the amount of \$1,000 to the author of the best book published in the two previous calendar years in ecumenical church history. "Ecumenical" is to be construed as concerned chiefly with problems of Christian unity and disunity (doctrinal, cultural, institutional) or with interactions between Christianity and other religious movements in any historical period. Authors of eligible books or any member of the Society may nominate titles for consideration; authors should submit a copy of the book. Nominations must be received by 1 March in even-numbered years.

The Philip Schaff Prize is an award in the amount of \$1,000 to the author of the best book published in the two previous calendar years, originating in the North American scholarly community and presenting original research on any period in the history of Christianity. Authors of eligible books or any member of the Society may nominate titles for consideration; authors should submit a copy of the book. Nominations must be received by 1 March in odd-numbered years.

The Jane Dempsey Douglass Prize is an annual award in the amount of \$250 for the author of the best essay published during the previous calendar year on any aspect of the role of women in the history of Christianity. Authors of eligible articles and any member of the Society may nominate titles for consideration. Nominations, accompanied if possible by a copy of the article, must be received by 1 August.

The Sidney E. Mead Prize, offered annually, is an award in the amount of \$250 for the author of the best unpublished essay in any field of church history written by a doctoral candidate or recent graduate whose manuscript stems directly from doctoral research. The manuscript will be published in *Church History*. Entries of no more than twenty-five double-spaced pages, including double-spaced endnotes, must be submitted by 1 July.

A work may be submitted for only one ASCH competition. **For more information, or to nominate a book or submit a manuscript, write to the American Society of Church History, P.O. Box 8517, Red Bank, NJ 07701.**

Church History: Studies in Christianity and Culture is published four times per year (March, June, September, and December) by the American Society of Church History. Membership dues for individuals are \$40 per year for regular membership, \$20 per year for retired persons who previously held regular membership for at least five years; and free for two years for graduate students with the approval of a professor who is a member of the Society (after two years, graduate students pay \$20 annually until graduation). Institutional subscriptions are \$60 per year. Foreign postage is an additional \$15 per year. Single issues are \$20. Please make remittances payable to "American Society of Church History."

Send manuscripts, books for review, and requests about advertising to the editorial office. Manuscripts should run 6,000–11,000 words (or approximately 20–35 pages), not including endnotes, and should be printed double-spaced in 11- or 12-point font; endnotes must be printed double-spaced on separate pages following the text. The editors request (1) three copies of the manuscript (in order to protect the author's anonymity during the review process, the author's name should appear only on the title page of the essay); (2) three copies of a 200-word abstract (if *Church History* publishes the essay, the abstract may be printed above the first line of the text of the article and/or it may be included on the forthcoming *Church History* webpage); (3) a 3½-inch diskette containing the manuscript and abstract (instead of sending a diskette, you may submit your manuscript and abstract by electronic mail). Further guidelines are available on request.
