Scott, Solicitor of the Department of State, as Secretary; Charles Henry Butler Corresponding Secretary, and Chandler P. Anderson Treasurer. Secretary of State Root officiated as President, and the members in attendance included Gen. Horace Porter, John W. Foster, and Oscar S. Straus.

The plan for the publication of The Quarterly of International Law, which will form one of the features of the society's work, and other matters were discussed, and the meeting adjourned subject to the call of the President. The object of the society, which originated at Lake Mohonk last year, is to promote the study of international law and its development.
