This book describes how Efik society and its domestic economy were modified, as the people of Old Calabar turned from fishing to slave trading, and then to trade in palm produce. This volume presents the text and translations of the most extensive myth to have been recorded in tropical Africa. The LoDagaa of northern Ghana tell the story of the creation of man and of his culture and recount his relationship with the creator God and with the beings of the wild who transmitted his culture. The struggle of God and the beings for man's concern explains the rituals of the Bagre society with which this myth is associated.
