CONTRIBUTORS

MICHAEL FRENCH is lecturer in economic history at the University of Glasgow. He received his Ph.D. in 1985 from Birkbeck College of the University of London. The article in this issue of the *Business History Review* originated in research on technical change and concentration in the U.S. tire industry that formed part of his doctoral dissertation.

THOMAS F. HUERTAS is assistant to the vice chairman of Citicorp/Citibank and is responsible for economic analysis of the strategic and regulatory issues facing Citicorp. He is the coauthor (with Herbert Van B. Cleveland) of *Citibank, 1812–1970* (1985) and the author of numerous articles on the history and regulation of the financial services industry. His publications include *Conflict and Accommodation: Coal Miners, Steel Workers, and Socialism, 1890–1920* (1982).

STEPHEN SHMANSKE is associate professor of economics at California State University, Hayward, and also serves as an economic consultant for the law offices of Stevens and Stevens in San Francisco. He received his Ph.D. from the University of California, Los Angeles, in 1982.
