## THE LAW OF STAMP DUTIES

Four Finance Acts have been passed, each of which has made one or more changes in the law. The most important of these was the Finance Act, 1963 which halved all the major *ad valorem* duties, and completely recast the duties on Bearer Instruments as well as making a number of other changes.
