

townspeople would have voted against the Nazi regime: would have regarded the atomization of German society, the regimentation, the introduction of the terror system, the everlasting round of dull propaganda rituals, and the domination of everything by the local Party chief to have been too high a price to pay for the economic gains which everyone could see and welcome. Of course this judgment cannot be proved or disproved. Again, however, the manner in which the nation supported Hitler in World War II does not suggest that most Germans thought the cost of Nazism excessive.

Altogether Allen has written a most interesting and valuable study of just what it meant in an ordinary German country town to pass from the Weimar era into the iron age of Nazism. We should hope that other scholars will undertake similar studies of other German towns with different religious, political, and social patterns.
