CALENDAR OF MEETINGS

Special Meetings on Latin America

Regional Conferences concerning International Education Act Regional conferences were sponsored by at least nine universities or associations to consider pro-

grams to be carried out when appropriations for implementation of the International Education Act, passed by Congress in 1966, become available (see LARR II:2, p. 199). The House Subcommittee on Appropriations put aside a request for \$350,000, failing to provide funds to set up a National Advisory Committee which would begin full-scale planning for implementation of the Act and endangering appropriation of the requested \$20 million for fiscal 1968. The Senate Committee on Supplemental Appropriations approved \$150,000 to be used in establishing 10 staff positions in the Department of Health, Education, and Welfare and to complete a basic organizational study, but hearings were yet to be conducted on the \$20 million appropriation. As of August 1, \$300,000 had been appropriated by the Senate for use in establishing the National Advisory Committee, for study in determing the status of international education in U.S. institutions, and the planning of a Center for Educational Cooperation in the Department of Health, Education, and Welfare. Conferences were conducted in Chicago, May 2, sponsored by the Committee on Institutional Cooperation, and May 3, sponsored by the Associated Colleges of the Midwest and the Great Lakes Colleges Association; in St. Louis, May 20, sponsored by Washington University; in Tucson, May 22, sponsored by the University of Arizona; in Boulder, June 12, sponsored by the University of Colorado; at Wentworth-by-the-Sea, June 16, sponsored by the New England Center for Continuing Education; in Palo Alto, July 7, sponsored by Stanford University; in Ithaca, August 7, sponsored by Cornell University; and in Los Angeles, fall 1967, sponsored by the University of California. International Conference on Social Psychological Research for Developing Countries—Ibadan, Nigeria December 29, 1966–January 5, 1967 Almost 100 delegates and observers participated in symposia concerning motivational aspects of technological development, problems of education and diffusion of

knowledge, and current issues of social psychological research. In addition, there were a number of discussion groups and informal working parties. Delegates from Latin America included Arrigo L. Angelini, University of São Paulo; Rogelio Diaz-Guerrero, UNAM; and Carlos Alberto Sequin, Peru. Conference proceedings are to be published jointly by the University of Ibadan Press and the *Journal of Social Issues*.

Colloquium on Factors of Integral Development of Latin America Brussels, February 10–12, 1967 Presentations at this meeting, organized by the Maison de l'Amérique Latine of Brussels, were: Reform-Revolution-Inte-

gration by M. Niedergang, journalist for *Monde*, Paris; Pressure Groups by A. Vanistendael, Confédération Internationale des Syndicats Chrétiens (CISC); Economic Sociology by M. Chaumont, Université de Louvain; Culture and Development by F. Bourricaud, Université de Bordeaux; Reality of the Latin American Free Trade Association by Carlos Maria Romero, Uruguayan ambassador; Toward the Integration of Latin America by J. Baeck, Institut des Pays en Voie de Développement, Université de Louvain; and Development and the Change in Elites by L. Mercier-Vega, Instituto Latino-Americano de Relaciones Internacionales. 3rd Special Inter-American Conference—Buenos Aires February 15–27, 1967 A primary purpose of the meeting was to adopt amendments to the Charter of the Organization of American States. The proposed

amendments incorporated into the OAS' basic treaty the economic and social objectives of the Alliance for Progress. They contain more detail than the original standards. Other amendments involved structural changes in the OAS, revisions of nomenclature, and changes in functions and procedures. This is the first set of extensive amendments since the founding of the OAS in 1948. President of the Conference was Argentine Foreign Minister Nicanor Costa Méndez. Representatives of all delegations comprised the two working committees which

produced the word-by-word reviews of the Charter amendments. Two documents were issued as a result of the deliberations at the meeting: Protocol of Amendment to the Charter of the Organization of American States (known as the Protocol of Buenos Aires) and the Final Act. The April 1967 issue of OAS Chronicle (Vol. II, No. 5) contains detailed coverage of the sessions and documents of the Conference.

Oshkosh Latin American Conference Oshkosh, Wisconsin, April 14-15, 1967 Latin America: Reform or Revolution was the subject of a program presented by the Department

of History and the Division of Extended Services of Wisconsin State University. Subjects under scrutiny were Revolution in Freedom: the Christian Democratic Party in Chile, the Culture of Poverty, the Role of the Military in Latin American Politics, and the Youth Revolution. Guest speakers were Edwin Lieuwen, University of New Mexico, who evaluated military activity in Latin American politics, Oscar Lewis, University of Illinois, who considered The Culture of Poverty, and Marcos Kohly, Miami Office of the Organization of American States, who spoke on the The Role of the Youth. Organizer of the meeting was Kenneth J. Grieb, Department of History, Wisconsin State University, Oshkosh, Wisconsin.

Southern Illinois University Pan American Week Conference Carbondale, April 19–22, 1967 A Conference on Rubén Darío: Symbol of Latin American Cultural Unity was convened during the 14th annual Pan American

Festival of Southern Illinois University's Latin American Institute. The program included papers by a number of scholars from Latin America and the Midwest.

Conference on Revival of the Hispanic American Report Palo Alto, April 29, 1967 Representatives of some fifty universities participated in the sessions. Agreement was unanimous that the *Hispanic American Re-*

port should be revived, and considered as a national rather than a local enterprise, governed by a committee representing a consortium of universities. Four organizational plans were considered, and a small majority favored publication of the journal by a special institute, in the tradition of the old *Report* (see p. 159).

1st Chilean Seminario Economía 1967 Jahuel, May 12–13, 1967 Thirty economists presented papers on economic theory, money, public finance, economic develop-

ment planning, mathematical economics, econometrics, transportation, agricul-

tural economics, and water resources. Sponsored by the Universidad Católica de Chile, the Universidad de Chile and the Universidad de Concepción, this was the first meeting of its kind to be held in Chile. Latin American Colloquium Waltham, Massachusetts, May 12-14, 1967 Sponsored by the Department of Sociology of Brandeis University, the colloquium comprised nine

sessions. Considerations of the sessions were: 1) developmental models and theories of structural change, with speakers Helio Jaguaribe, Irving L. Horowitz, Marcio R. Monteiro, and Robert A. Packenham; 2) methodology and problems of research, with addresses by Kalman H. Silvert and Peter D. Bell; 3) Cuba, with speakers Paul M. Sweezy, Edward Boorstein, and Victoria Ortiz; 4) the Mexican case, with papers by John Womack, Jr., Stanley M. Davis, and José Luis Vega; 5) the Venezuelan case, with speaker José Agustín Silva-Michelena; 6) an Argentina panel, addressed by Gino Germani and Juan Eugenio Corradi; 7) Central America, with a paper by John Saxe-Fernández; 8) Brazil, with speakers Octavio Ianni, Tocary Assís Bastos, Paul Singer, Juarez R. B. Lopes, and Helio Jaguaribe; and 9) urbanization in Latin America, addressed by José Luis Romero, John Turner, William Mangin, and Anthony Leeds.

Conference on Problems of Urbanization in Latin America—El Paso, June 9–10, 1967

The Conference was sponsored by the Inter-American Institute and Department of Political Science

at the University of Texas at El Paso (formerly Texas Western College). International organizations and interested U.S. government agencies participated, as well as university researchers. Principle addresses were: Urbanization Trends in Latin America by Fabio Dasilva, Department of Sociology, University of Texas at El Paso; Aspects of Urban Structure and Form in Latin America by Walter D. Harris, Department of Architecture, Yale University; Community Development and Urban Planning by Francis Violich, Department of City and Regional Planning, University of California, Berkeley; and Urban Characteristics of Cities in Northern Mexico by Francisco Ruíz Obregón, Junta Federal de Mejoras Materiales, Cd. Juárez, Mexico. Publication of the proceedings is to be handled by the Bureau for Public Affairs, University of Texas at El Paso, El Paso, Texas 79902. Interest manifested by the participants at the June meeting justifies the continuation of annual meetings as a series on Urbanization in Latin America; others will focus on urban problems and planning of the Mexico-U.S. borderlands, Central America, the Andean highlands, and other Latin American geographical areas. The next meeting is tentatively scheduled for Augest 1968

Symposium on Problems of Stratification and Migration—Lima, August 7-10, 1967

Primary considerations at the meeting sponsored by the Asociación Peruana de Antropólogos

(APA) were social stratification, migrations, and social mobility. Also included was a Mesa Redonda which channelized the conclusions of the sessions. Organized in 1966, the Asociación has as its general goals the facilitation of cooperative efforts by international universities in the study of anthropology, as well as elaboration of professional programs. A newsletter, the *Boletín*, is published by the APA, Apdo. 383, Lima, Peru.

1st World Conference on Education in the Labor Movement—Montreal August 16-25, 1967

H. A. Tulatz, Assistant General Secretary of the International Confederation of Free Trade Unions (ICFTU), sponsoring organiza-

tion, organized the meeting which was attended by international trade union leaders, educators holding responsible positions in the labor movement, and representatives of international agencies active in education. In preparation for the meeting, the 2nd ORIT Inter-American Conference of Directors and Experts in Labor Education was held August 11–14 at the ORIT-ICFTU Inter-American Labor College, Cuernavaca, Mexico. Participants considered labor education programs of international bodies and specialized agencies, national machinery for the promotion of labor education, and the societal role of labor education and adopted recommendations to be subsequently presented to the 1st World Conference on Education in the Labor Movement.

Meeting on Population Policies in Relation to Development in Latin America Caracas, September 11–16, 1967 Sponsoring the meeting were the Pan American Health Organization (PAHO), The Population Council, the Aspen Institute for

Humanistic Studies, and the OAS. A preparatory seminar was held last February to lay the technical guidelines for the Caracas meeting. It was decided that population policy should be considered in light of its direct influence on probable numbers of population, age composition, family size, and regional and rural-urban apportionment and with regard given to the effects that changes in the social processes—especially in education, housing, health, and employment—may have on those variable factors. Participants of the February seminar attended the meeting, along with ministers of health, education, labor, and agriculture as well as heads of various planning offices of the OAS member nations.

Recurring Meetings

4th Inter-American Meeting on Educational Planning—Washington, D.C., November 28-December 9, 1966 Theme of the meeting attended by 36 representatives of OAS member countries' Ministries of Education and observers from

international organizations was the improvement of educational statistics. An examination was conducted of the situation of statistics in Latin American education, with attention given to the administrative factors of the national statistical services and those personal, legislative, or technical factors which facilitate or impede the production of statistics. In regard to international cooperation for improving educational statistics, the conference made recommendations for national services, censuses of household patterns, formation of improved personnel through courses and seminars, and diffusion of statistical information. A complete version of the activities and recommendations of the conference is included in a special publication of the Department of Educational Affairs, Pan American Union, Washington, D.C. 20006.

7th Seminar of the Program of Studies on Economic Integration in Latin America Guanajuato, December 12–17, 1966 Eighteen economic research institutions representing Argentina, Brazil, Chile, Colombia, Ecuador, Mexico, Paraguay, Peru, Uruguay,

and Venezuela participated in the Seminar. The Brookings Institution coordinated the studies. Final results of the regional integration of industries in the LAFTA region study were discussed, as were future projects for investigation. The Centro de Investigaciones Económicas (CIE) of the Instituto Torcuato di Tella, Buenos Aires, will take part in the international study on consumption and income levels in the LAFTA countries.

8th AIESEC-US National Conference and International Seminar—Rio Piedras, Puerto Rico, December 27, 1966— January 3, 1967 Students from many countries of the Western Hemisphere attended the student-managed Seminar, which was held in conjunction with the Conference of the Associ-

ation Internationale des Etudiants en Sciences Economiques et Commerciales (AIESEC), United States section. Theme of the Seminar was Economic Integration Efforts in America. Papers delivered included: Philosophy and Goals of Integration in America by José Cárdenas, advisor of Economic Integration, Inter-American Development Bank; with others by Rolando Castañeda, Department of Economics, University of Puerto Rico, at the session Economic Bases for Integration; Luis A. Passalacqua, Executive Director, Caribbean Development Corporation, Puerto Rico, at a session on The Caribbean—Its Im-

portance in an Integrated America; and Aaron Segal, University of Puerto Rico, during a discussion of Future Steps for an Integrated America. Papers and commentary are being published by the AIESEC Chapter, University of Puerto Rico, College of Business Administration, Rio Piedras, Puerto Rico 00931.

Annual Meeting of Society of Architectural Historians Cleveland, January 27, 1967 Architectural historians and two archaeologists presented differing methods of thought and points of view on the two main disciplines

dealing with pre-Columbian architecture at a special session devoted to the subject. Paper titles were: Puuc Architecture: Definition of a Style by Edward T. Hinderliter, Media, Pennsylvania; The Architecture of Tikal and Its Links with the Style of the Chenes and Puuc Regions by Marimar Benitez, Tulane University; Systems of Architectural and Sculptural Design at El Tajin by Michael E. Kampen, University of Pennsylvania; Sociocultural Implications of House Types in the Teotihuacán Valley by Thomas H. Charlton, Grinnell College; and Urban Planning in Ancient Teotihuacán by Rene Millon, University of Rochester.

2nd Congress of Latin American Writers Guanajuato and Guadalajara March 14–24, 1967 An outgrowth of the Latin American Cultural Community, which held its first Congress in Arica, Chile in 1965, the Community of

Latin American Writers is headquartered in Mexico City. The Mexican government sponsored the Congress, which was called "Second" to show continuity with the earlier meeting. Co-chairmen of the Congress were Brazilian novelist Guimaraes Rosa and Miguel Angel Asturias, Guatemalan novelist. The principal considerations of the meetings were to find ways of increasing personal contacts among the writers of Latin America and encouraging a greater flow of publications across national boundaries. Also, committees considered possibilities of uniform copyright laws and an easing of the existing tax burdens on foreign authors, as well as the working conditions and publicity benefits of authors in the United States or Europe as compared to those in Latin America. The establishment of state publishing houses was advocated by the participants. Attention was also directed to the social function of the writer and his relevance to education and culture.

Encuentro Latinoamericano del Movimiento Familiar Cristiano Temuco, Chile, March 24–26, 1967

Approximately 70 persons attended the sessions, considering The Demographic Problem, Its Dimensions and Possible Solu-

tions. Aspects within the general theme included study of the global and fa-

milial societies and interdependence between them, complexities of the demographic problem, facets of interdisciplinary solutions, and necessity for a politics of population in Latin America.

8th Meeting of the Board of Governors of Inter-American Development Bank Washington, D.C., April 24–28, 1967 Participants at the meeting reviewed IDB's contributions to Latin American economic development during 1966. A general

summary of the meeting has been published by the Bank, 808 17th Street, N.W., Washington, D.C. 20577.

Regional Conference of Society for International Development—Washington, D.C., April 29, 1967 Under the general theme of Regional Integration and Development, one panel discussed Regional Integration as a Pre-Con-

dition for Development—Latin America, a Case Study. Panel chairman was Walter J. Sedwitz, Department of Economic and Social Affairs, Organization of American States.

Comparative Study of Rural Surveys Bogotá, May 11, 1967 The conference was sponsored by the Centro Latinoamericano de Demografía (CELADE) and the

División de Estudios de Población of the Asociación Colombiana de Facultades de Medicina. Hernán Mendoza Hoyos, chief of the División, organized the meeting, which was part of a preliminary set of meetings prior to the establishment of a definitive survey of rural fertility in November 1967. Preliminary investigations in the surrounding areas of Cartagena (organized by Abel Dueñas P., Facultad de Medicina, Universidad de Cartagena, Apdo. Aéreo 13–82) and Manizales (conducted by Nelson Lennis, Facultad de Medicina, Universidad de Caldas, Apdo, Aéreo 257) were considered. Publication of papers and commentary concerning the surveys will be handled by CELADE, Avenida José Manuel Infante 9, Santiago, Chile.

Comparative History Seminar Viña del Mar, July 3-6, 1967 Slavery in the Americas was the theme of the gathering which was sponsored by the Fulbright Com-

mission of Chile. A successful attempt was made to compare the institutions of slavery in the United States and in Latin America. Papers included: Aspectos socio-económicos de los negros en el Litoral Argentino durante los siglos XVI, XVII, y XVIII, by Samuel Gorbán, Universidad de Santa Fé, Rosario, Argentina; Esclavitud negra como factor económico y social en el complejo de la empresa jesuítica en el Perú by Fernando Ponce, Universidad Agraria, Lima, Peru;

The Role of Free Colored Peoples in Hispanic America by James F. King, University of California, Berkeley; Libertad de los esclavos ante la opinión social de la Nueva Granada a mediados del siglo XIX by Jaime Jaramillo Uribe, Universidad Nacional, Bogotá, Colombia; and Socio-economic Conditions in the U.S. South After the War of Secession by Carl N. Degler, Vassar College. Papers and commentary are to be published in December 1967 by the American Embassy, Santiago, Chile.

8th Seminar of the Associated Latin American Economic Research Institutes Asunción, July 10–15, 1967 Sponsors of the Seminar were Centro Paraguayo de Estudios de Desarrollo Económico y Social (CEPADES) and the Brookings

Institution. Joseph Grunwald, director of Economic and Social Development Studies at Brookings, organized the meeting. Specific studies regarding Latin American economic integration were considered by the 17 participating research institutions, representatives of the sponsoring groups, and observers from international organizations such as OAS, INTAL, and IDB. Of particular interest were studies of consumption, international price comparisons, and salary structures of Latin America. 3rd Brazilian Seminar of Linguistic Orientation—Porto Alegre July 17–21, 1967 Principles of Linguistics and Applications to Foreign Language Teaching preoccupied participants at this meeting sponsored by the

Centro de Lingüística Aplicada, São Paulo. F. Gomes de Matos was responsible for the meeting's organizational details. Papers presented included: The Application of Linguistics to Secondary School Teaching of Brazilian Portuguese by Joselice Macedo, Universidade Nacional, Rio de Janeiro; Linguistics and Pronunciation Problems of Brazilians Learning English by Adair Palácio, Centro de Lingüística Aplicada; Linguistics and Training of Foreign Language Teachers in Brazil by Augustinus Staub, Universidade de Brasilia; Linguistics and Anthropology in Brazil by Aryon Rodrigues, Museu Nacional, Rio de Janeiro; Dialectological Studies in Rio Grande do Sul by Heinrich Beunse, Universidade Federal do Rio Grande do Sul; and A Fragment of Contrastive (syntactical) Analysis English-Brazilian Portuguese by F. Gomes de Matos, Centro de Lingüística Aplicada. Some of the papers delivered at the session will be published in Estudos Lingüísticos, a Brazilian journal of theoretical and applied linguistics published by the Centro de Lingüística Aplicada, Instituto de Idiomas Yázigi, Rua Aurora, 713–5° Andar, São Paulo 2, Brazil.

3rd Colloquy on Ibero-American Economics—Toulouse, France July 24–28, 1967 Title of the meetings attended by French and Latin American economists was Toward a New Foreign Trade Policy. Papers included:

Co-production and International Commerce, National Power and Economic Development of Latin America, Movements of Capital between "Great Nations" and "Small Nations," the Notion of the Small Nation and Foreign Trade, Exchange Rates, and the Formation of Capital. 6th Caribbean Conference on Mental Health—Bridgetown, Barbados July 30-August 5, 1967 Sponsoring the Conference were the World Federation for Mental Health, the Caribbean Federation for Mental Health, and the

Barbados Mental Health Association. Society and Its Responsibility for Mental Health was the theme, with the following subtopics: The Home and Mental Health, The School and Mental Health, Religion and Mental Health, The Law and Mental Health, Industrialization and Its Effect on Mental Health, Family Planning and Mental Health, The Role of Voluntary Organizations in a Mental Health Program, and Mental Health Associations—Their Function in Society. Meeting of World Association for Public Opinion Research Vienna, August 20–24, 1967 Topics with relevance to Latin America were The Consumer and Consumption Patterns in the Developing Countries of Asia,

Africa, and Latin America, with a paper delivered at that session by Miguel Gorfinkiel of Argentina entitled Latin American Consumers.

2nd Simposium Americano de Arte Rupestre—Huánuco, Peru August 21–26, 1967 The development of studies of arte rupestre, that which is engraved in rocks and caves, was considered by participants at the

sessions held at the Universidad Nacional "Hermilio Valdizán" de Huánuco. Organizer of the symposium was Edmundo Guillen Guillen, Facultad de Letras y Educación at the university.

14th Annual Meeting of The Institute of Management Sciences—Mexico City August 22–25, 1967

The Institute of Management Sciences (TIMS), at the Centro Médico, Mexico City, sponsored the meeting which comprised ses-

sions on Management Sciences: Needs and Opportunities in Latin America, Education for Management and Management Science, Automation Computation and Control of Factory Operations, Models for Controlling and Guiding Growth, Nonlinear Problems and Combinatorics, Probabilistic Programming and Game Theory, Plant Location and Country Development, Management Science in Government and Public Administration, Traffic and Transportation Planning, and Man-Machine Systems and Their Place in Economic Planning. Responsible for organizing the meeting were A. Charnes, Northwestern University, and W. W. Cooper, Carnegie Institute of Technology. Participation was international, including many Latin Americans interested in the various topics of management sciences. The journal of TIMS, Management Science, will assume refereeship concerning publication of papers or commentary concerning the meeting.

Annual Convention of American Association for Education in Journalism Boulder, August 27–31, 1967 All aspects of education in journalism were considered by Association members at the meeting, which was organized by John D.

Mitchell, School of Journalism, University of Colorado, Boulder, Colorado. Several programs with specific Latin American content were conducted by the Division of International Journalism, chaired by John Adams, School of Journalism, University of North Carolina. Selected papers and commentary will appear in the *Journalism Quarterly* during 1968.

World Family Congress—Quebec August 27–September 2, 1967

New Families in Society was the theme around which sessions were organized. Discussions involved:

1) studies on the prevailing legislation concerning the founding of a family—reciprocal duties and rights of husband and wife, and on the attitude of new families concerning these laws; 2) the living standards of new families; 3) housing for new families, with a subsection dealing specifically with the situation in Latin American countries; and 4) social adjustment of new families.

Annual Meeting of Pacific Coast Branch of American Historical Association—Stanford, California, August 28–30, 1967 The theme of one of the sessions at the meeting was The Mexican Revolution: Prelude and Postlude. Papers included: The Brinton

Thesis and the Mexican Revolution by Charles E. P. Simmons, University of

Idaho, and Ruth Hafter, Dalhousie University; and The Nazas River Controversy Before the Mexican Revolution by Clifton B. Kroeber, Occidental College. Theodore E. Treutlein, San Francisco State College, chaired the session with Woodrow W. Borah, University of California, Berkeley, and Manuel Servín, University of Southern California, acting as critics.

8th Congreso Latinoamericano de Sociologia—San Salvador September 1–5, 1967 The agenda included considerations of the sociology of regional integration, conducted by Alejandro Marroquín, social problems of

economic development, conducted by Pablo González Casanova, sociology of the university, conducted by Aldo Solari, and social projections of agrarian reform in Latin America, conducted by Antonio García. A *Memoria* of the congress will be published in late 1968 by the Facultad de Humanidades, Departamento de Ciencias Sociales, Universidad de El Salvador, San Salvador.

Daedalus Conference on Latin America Boston, September 6–12, 1967 Sponsored by *Daedalus*, the journal of the American Academy of Arts and Sciences, Boston, Mas-

sachusetts, this was a closed conference. Results of the meeting will be published in *Daedalus* in early 1968.

Annual Meeting of Directors of Development Training and Research Institutes—Montpellier, France September 7–12, 1967 General theme of the meeting was Regional Development and its Multidisciplinary Aspects. Approximately 60 participants from the Americas, Africa, and Asia at-

Within consideration of administrative and organizational problems related to regional development, particular reference was given to the situation in Argentina by José María Dagnino Pastore, Ministro de Economía y Hacienda of the Province of Buenos Aires and director, Fundación de Investigaciones Económicas Latino-Americanas (FIEL).

Meeting of Committee on Regional Geography of PAIGH—Ottawa September 11–13, 1967 An exchange of views and information among Committee members who are nominated by officials of the Pan American Institute of

Geography and History (PAIGH) in their respective countries was provided

by the meeting. Participants included teachers, military figures, engineers, and others with related interests. Selected papers on the implementation of various regional development schemes in Latin and Anglo America were included. Delegates with an interest in the more theoretical aspects of development planning were enabled to participate in the Seminar on the Definition of Regions for Development Planning, also held in Ottawa during the same week. Seminar participants considered standardized procedures and criteria for the recognition and definition of regional units in Latin American countries which are optimal for the administration of development programs. A two-year testing period will be conducted to find answers to development planning, after which a second seminar will be held in the spring of 1969.

7th Conference on the History of Western America—San Francisco October 12–14, 1967 Sessions at the Conference sponsored by the Western History Association with special interest to Latin Americanists included one

on Maritime Exploration on the West Coast, chaired by Donald C. Cutter, University of New Mexico, and one on The Spanish Borderlands, chaired by Donald E. Worcester, Texas Christian University. At the Banquet of the Western History Association, Earl Pomeroy, University of Oregon, spoke on The West and New Nations in Other Continents.

23rd Annual Meeting of the Inter-American Press Association San Juan, Puerto Rico, October 13–20, 1967 Freedom of the press in the Americas was the primary consideration at the meeting, which was organized by Carlos A. Jiménez. Repre-

sentatives of newspapers and other periodical publications in the Western Hemisphere and persons otherwise connected with the newspaper business attended. The annual session was broken down into a meeting of the Committee on Freedom of the Press, October 13–14, meeting of the Board of Directors, October 16, and the 23rd Annual Assembly, October 17–20. Milbank Memorial Fund Meetings New York, October 17–19, 1967 Two Round Tables, held simultaneously, considered Current Research on Fertility and Family

Planning in Latin America, and Social Science and Health Planning in Latin America. Organizers of the sessions were Clyde V. Kiser and Robin F. Badgley, respectively. Participation was by invitation only. As for the session on Current Research on Fertility and Family Planning, Latin American and North American physicians and social scientists considered needed research in the topical areas, based on official data and special studies. Other physicians, social scientists, and public health officials considered at the Round Table on Social Science and Health Planning the problems of social science in the health fields, using the Colombian National Health Manpower Survey as a case study.

INSTITUTIONAL NEWS

Agency for International Development Research Programs Reorganized

Plans for the reorganization of the Agency for International Development have been considered in earnest since February 1967. Of interest to universities were plans to implement a carefully designed program in agriculture and the related priority given to the grants program which enables universities to carry out AID-contracted research.

For administrative convenience and because of their close relationship with other activities in the Office of the War on Hunger, responsibility for the administration of the entire central research and institutional grants programs of the Agency were separaed from the Office of Technical Cooperation and Research and assigned to Erven Long, under the general supervision of Herbert Waters, assistant administrator, Office of the War on Hunger. In addition to direct responsibility for these two programs, the Research and Institutional Grants Staff under Long's direction will serve as a central point of contact for all university activities related to agriculture and other programs of the Office of the War on Hunger. Beyond the scope of the latter group are responsibilities for developing AID policy regarding research, including standards and criteria for sponsorship, design, review, approval, monitoring, financing, and performance of the research.

Central responsibility for education programs as such has been transferred from Technical Cooperation and Research to the Office of Program Coordination. The special assistant for university relations resides in this office, and, in addition to education programs, is concerned with contract and publications policy and other matters involving the AID-University Advisory Committee.
