CONTRIBUTORS

Manuel Barcia is Professor of Latin American History at the University of Leeds (West Yorkshire). He is the author of three books and several articles focusing on the history of the African diaspora in Latin America and the Caribbean. His most recent book, *West African Warfare in Bahia and Cuba: Soldier Slaves in the Atlantic World, 1807–1844*, was published in 2014. In the same year, he was awarded a Philip Leverhume Prize in History. He is one of the editors of the journal *Atlantic Studies: Global Currents*.

Cameron D. Jones is a lecturer at California Polytechnic State University in San Luis Obispo, California. He has received numerous fellowships and awards including a Fulbright-Hayes Doctoral Research Abroad Fellowship, an Academy of American Franciscan History Fellowship, and a Bradley Military History Fellowship. His current book, *In Service of God and King: The Missionaries of Ocopa, Indigenous Resistance, and the Changing Nature of Spanish Governance in Bourbon Peru, 1709–1824*, was recently accepted for publication by the Academy of American Franciscan History.

Douglas Cole Libby is Professor of History at the Universidade Federal de Minas Gerais and senior research fellow at the Conselho Nacional de Desenvolvimento Científico e Tecnológico. He has authored and edited a number of books in Brazil, and has also published in more than a dozen academic journals there. He has recently published articles in *African Economic History*, *Journal of Family History*, and *Luso-Brazilian Review*. His current research focuses on the history of cotton in Brazil.

Owen H. Jones, an Assistant Professor of Latin American History at Valdosta State University in south Georgia, is a specialist in the colonial K'ichee' and Yucatec Maya. His doctoral research revealed how the K'ichee' and the Maya adapted imposed colonial institutions and restructured them to function in conventional indigenous society. His work is informed by his careful deconstructions of colonial documents written in the K'ichee', the Yucatec Maya, and the Spanish languages. His publications include “‘One Or Two of My Living Words,’ Seventeenth- and Eighteenth-Century K'ichee' Testaments from Guatemala,” a chapter in the forthcoming *Dead Giveaways II* (University of Utah Press). His current work focuses on K'ichee' practices of law, jurisprudence, and the quest for justice in colonial Guatemala.
