Proposals should be developed with the Editor.

Manuscripts should be typewritten, double-spaced, with footnotes, references, tables, and charts on separate pages, and should follow the current journal style. A brief biographical paragraph describing each author's current affiliation, research interests, and recent publications should accompany the manuscript.
