# The Birth of the English Common Law

R. C. van CAENEGEM

How and when did the English Common Law originate? Why is it so different from the law of the other European countries? Professor van Caenegem provides in this book his challenging interpretation of the emergence of the English Common Law, seen against the background of the legal history of Western Europe generally.

Professor van Caenegem describes in detail the development of the royal courts in Anglo-Norman England and their peculiar procedure, based on royal writ and the jury. Parallel developments on the continent are considered. He goes on to criticize the traditional view that the 'English national character' is the principal cause of the rise of the Common Law, and argues that chance and chronological accident played the major part in preserving a feudal law of continental origins.

The comparison between English and continental legal development will be of particular interest at a time when, with the entry of Great Britain into the Common Market, the difference between the civil law of the continent and the Common Law of England will constitute a major problem. It will become an important work of reference for all specialists in early legal history and medieval history.
