The idea that there was a time when men and women lived in perfect harmony with nature and with themselves, though rooted in classical antiquity, was one of the most fertile products of the Renaissance literary and artistic imagination. This book explores one specific aspect of this idea: the musical representation and stylization of the myth of Arcadia in sixteenth-century Italy. Giuseppe Gerbino outlines how Renaissance culture strove to keep this utopia alive and demonstrates how music played a fundamental role in the construction and preservation of this collective illusion. Covering a range of different musical genres, including the madrigal, music for theater, and early opera, the book overcomes traditional barriers among genres. Illustrative music examples, including previously unpublished music, serve to expand the reader's knowledge of this important repertory, and provide new insights into the role of music in the preservation of cultural myths.

- 1 Articles should be sent to Professor James Borders, The University of Michigan, School of Music, Theatre & Dance, 1100 Baits Drive, Ann Arbor, Michigan 48109-2085, USA, or to Dr Helen Deeming, Department of Music, Royal Holloway, University of London, Egham, Surrey TW20 0EX, UK. - 2 Books and recordings for review should be sent directly to the responsible editors, whose addresses may be found below. Material for inclusion in the Chant Bibliography should be sent to Dr. Günther Michael Paucker, Weinsteige 10, D-71384 Weinstadt, Germany <dr.g.paucker@gmx.de>.
- 3 Articles should not normally exceed 10,000 words including footnotes, tables and appendices. In the case of submissions that exceed this length, the editors should be consulted in advance. Authors should keep in mind that the journal addresses a wide readership; hence technical matters and specialised vocabulary should be clearly explained in a manner that will facilitate understanding by educated readers outside the author's field of specialisation. The language of publication is English, using British conventions of spelling and punctuation. Continental scholars may submit initial versions of articles in German, French, Italian, or Spanish. If the article is accepted for publication, it is the author's responsibility to arrange for an idiomatic English translation.
Double spacing must be used throughout (text and notes), and right margins should not be justified. Tables and captions must be typed separately from the main text, and the location of tables clearly indicated in the text. Footnotes should be limited to necessary documentation and should not include argumentation better placed in the text. Contributors are encouraged to submit plates, diagrams, maps, and line illustrations as digital files. Musical examples may also be submitted in electronic format (600 to 800 dpi TIFF files; postscript files are not acceptable).

- 4 An abstract of about 250 words summarising the content of the article and a short biographical statement should be supplied with the final version of the article.
- 5 When an article has been accepted for publication, the author must send a copy of the final version on computer disk (Apple Macintosh or IBM compatible PC) together with the (double spaced) hard copy typescript, giving details of the wordprocessing software used (preferably Microsoft Word).
- 6 Contributors are responsible for obtaining permission to use copyright material, and for making appropriate acknowledgement of both copyright and non-copyright matter.
- 7 Contributors will have an opportunity to check one set of proofs (in page) and should mark corrections following the guidelines enclosed with the proofs. Corrections should be restricted to printer's and publisher's errors. Author's corrections must be distinguished and may be charged for.
