## CONTRIBUTORS

*Edward J. Balleisen* is a postdoctoral fellow at the University of the Witwatersrand, Johannesburg. His dissertation, "Navigating Failure: Bankruptcy in Antebellum America," won the 1996 George Washington Egleston Prize for the best Yale Ph.D. in American history. In the fall of 1997, he will take up a position as assistant professor of history at Duke University, where he will teach courses on the nineteenth-century United States and continue research into the culture of American Capitalism.

*Daniel Barbezat* is associate professor of economics at Amherst College and is currently visiting associate professor at Northwestern University. He recently finished a book with Larry Neal on the European Union (forthcoming) and published an article with Jim Hughes on the basing-point pricing system of the "Stalwerksverband" in the *Journal of Economic History*.

*Robert Kargon* teaches the history of science at The Johns Hopkins University. Trained in physics at Duke and Yale, and in history at Cornell, Kargon is especially interested in the complex role of science in modern societies, in the evolution of method in physical science, and in scientific institutions as mediators between society and discipline. He was named Willis K. Shepard Professor of the History of Science in 1979.

*Barbara E. Kemmerer* is associate professor of management at Eastern Illinois University. She received her Ph.D. in 1990 from the University of Nebraska-Lincoln in Business Administration with a major in Organization Behavior. Her primary research interests include job attitude stability, group dynamics, management history, and classroom assessment. She has published articles in *The Academy of Management Journal*, *The Journal of Organizational Behavior*, *Group and Organization Studies*, and *Business Forum*.

*Stuart W. Leslie* teaches the history of technology at The Johns Hopkins University. He is the author, most recently, of *The Cold War and American Science*, and is currently studying high technology industry and regional economic development in the U.S. and abroad.

*Charles W. Wootton* is professor of accountancy at Eastern Illinois University. He received his D.B.A. in accounting from Mississippi State University. His research interests are accounting history and auditor concentration. He has published in journals such as *Abacus*, *The Accounting Historians Journal*, *Accounting Horizons*, and the *Journal of Accountancy*.
