# LAW AND THE SOCIAL ROLE OF SCIENCE

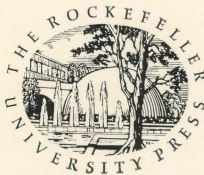

FRANCIS BACON proclaimed in his *Grand Instauration* that "a way must be found for the human understanding entirely different from any hitherto known." Bacon was a lawyer, not a professional scientist, but his words are wonderfully apt as a characterization of scientific method. Natural science, in its social role, is not an island entire unto itself. We must also look to the social sciences for guidance in introducing technological innovations. There are crucial decisions, too, as to the extent to which government should support research and the form such support should take—outright grant, contract, or preferential tax treatment. These are some of the political decisions, and they will be reached and implemented through government's instrument, the law.
