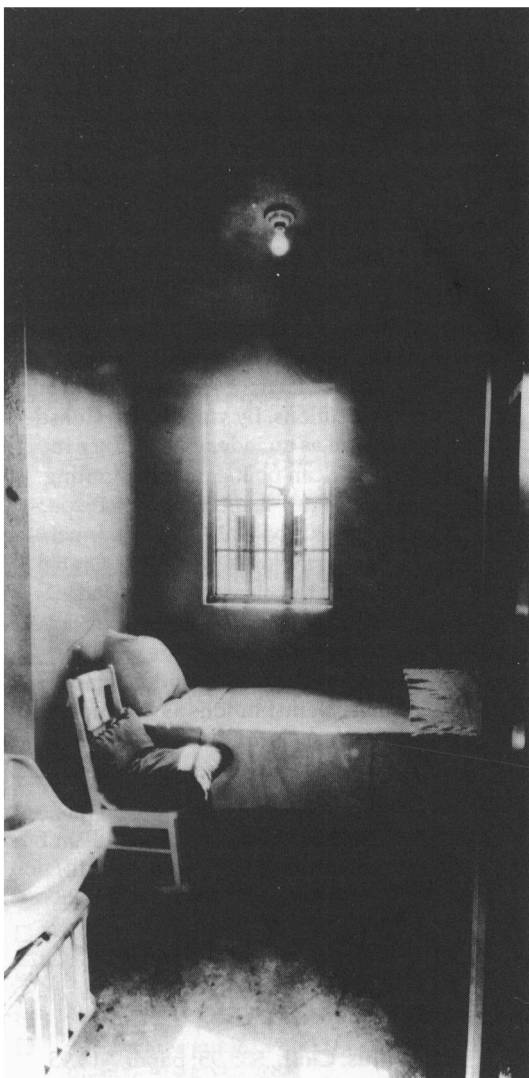

## **Crimes, Follies, and Misfortunes The Federal Impeachment Trials**

Eleanore Bushnell

Bushnell's meticulous scholarship and elegant prose make fascinating reading of a significant, yet little explored, subject. She discusses fourteen federal trials from 1799 to 1989, detailing accusations against each official and linking each proceeding to biographical and other information. Noting that eleven of the impeached officers were judges, Bushnell observes that criminality has not been a conspicuous cause of judicial misconduct. More common problems have included alcoholism, absenteeism, senility, and violations of ethical canons.

## **Set No Limits**

### **A Rebuttal to Daniel Callahan's Proposal to Limit Health Care for the Elderly**

Robert L. Barry, O.P., and Gerard V. Bradley

Can we put a price tag on life without devaluing it? Can we decide for someone else that life isn't always good and death isn't always bad? Should life be judged only by its "quality"? Are the elderly worth the cost of their own health care?

These and other tough questions are raised in *Set No Limits*, which cogently challenges age-based rationing schemes of the type proposed by Daniel Callahan in his highly publicized book *Setting Limits*. The founder and director of the Hastings Center, the nation's leading bioethics center and an institution whose policies often have been accepted as doctrine by the American Medical Association, Callahan has asserted that all medical care and treatment should be denied the elderly when they reach the end of their "natural life span," somewhere around—even before—80 years of age.

*Set No Limits* charges that such rationing would be unjust and profoundly biased. The contributors criticize the proposal from legal, economic, philosophical, medical, and religious perspectives. There is a thorough and unflinching critique of a concept that could become standard medical practice, as the U.S. health care establishment attempts to deal with ever increasing medical expenses.

## Note to Contributors

The editors welcome unsolicited manuscripts, books for review, and suggestions concerning *Law and History Review*. Manuscripts should be submitted to Bruce H. Mann, University of Pennsylvania Law School, 3400 Chestnut Street, Philadelphia, Pennsylvania 19104. The text should be typed, double-spaced, on 8½" x 11" paper with ample margins on all sides. Type on one side of the paper only. Footnotes should be typed double-spaced and separate from the text, and should conform to either the style found in the *Chicago Manual of Style* (13th ed.) or to *A Uniform System of Citation* (14th ed.); the *Chicago Manual* is preferred. Authors of accepted manuscripts should contact the editorial office regarding computer compatibility. Because of the commitment we ask of our outside referees, *Law and History Review* cannot consider for publication manuscripts that have been submitted to other journals. A submission to the *Review* carries with it the implicit promise that the author will not submit the manuscript elsewhere while it is under consideration by *Law and History Review*.
