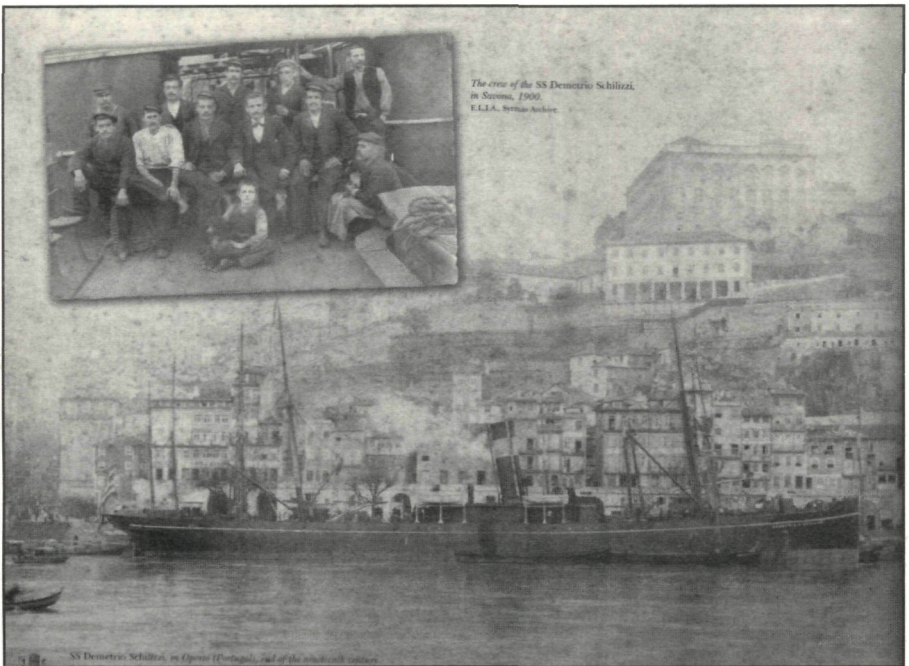

Contributors

Jennifer Delton is associate professor and chair of the History Department at Skidmore College. She is the author of *Making Minnesota Liberal: Civil Rights and the Transformation of the Democratic Party* (2002). Currently, she is writing a book entitled “Good Business: Integrating the American Workplace, 1930–1970,” which examines corporate efforts to curb racism and end discrimination before the introduction of affirmative action.

Gelina Harlaftis is associate professor and head of the Department of History at Ionian University in Corfu, Greece; she is also president of the International Association of Maritime Economic History. Her book *History of Greek-Owned Shipping* (1996) received the Runciman Award in 1997. More recently, she edited, with Ina Baghdiantz McCabe and Ioanna Minoglou, *Diaspora Entrepreneurial Networks: Five Centuries of History* (2005), and, with Maria Christina Chatziioannou, *Following the Nereids: Sea Routes and Maritime Business in the 16th–20th Centuries* (2006). She is currently conducting research on Greek maritime business in the Mediterranean in the eighteenth century and diaspora trading companies in global maritime business during the nineteenth and twentieth centuries.

David Merrett is professor in the Department of Management and Marketing at the University of Melbourne. He is currently examining the formation and influence of social capital during the transfer of the market for wool from London to Australia in the late nineteenth century; he is also conducting research on the history of competition policy in Australia and the long-term profitability of Australian business. His latest books are *The Big End of Town: Big Business and Corporate Leadership in Twentieth-Century Australia* (2004), co-written with Grant Fleming and Simon Ville, and *The Internationalisation Strategies of Small-Country Firms: The Australian Experience of Globalisation* (2007), which he co-edited with Howard Dick.

Simon Ville is professor and head of the School of Economics at the University of Wollongong, president of the Economic History Society of Australia and New Zealand, and a fellow of the Academy of Social Sciences in Australia. He is currently researching Australian and international economic and business history, including the rural industries, social capital, innovation, interorganizational communication, and the

long-term profitability of Australian business. Among his recent books are *How Organisations Connect: Investing in Communication*, which he edited with Gordon Boyce and Stuart Macintyre (2006); *Big End of Town: Big Business and Corporate Leadership in Twentieth-Century Australia*, which he wrote with Grant Fleming and David Merrett (2004); and *Rural Entrepreneurs: A History of the Stock and Station Agent Industry* (2000), which won the Bruce McComish prize for economic history.
