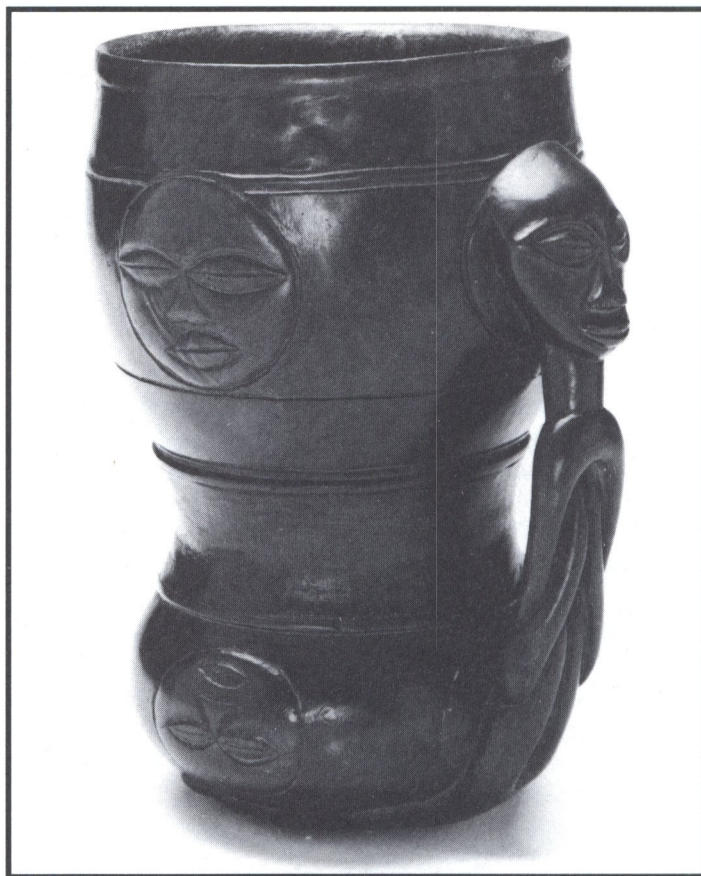

Avoid self-identification as author throughout article. Include a 250-word abstract. The ASR will only consider manuscripts that have not been published elsewhere and are not being considered by other journals.
