#### NOTES FOR CONTRIBUTORS

Contributions may be descriptive, analytical or theoretical. Any article that is not in itself comparative may be accepted if it lends itself to comment placing it in comparative perspective. Prior correspondence with any of the editors will help them in obtaining such comment or a companion study.

Emphasis in comparative studies may be either on similarities or, if these are significant enough and call for some recasting of generalisations, on differences.

All contributions and editorial correspondence should be sent to the Editors, *Comparative Studies in Society and History*, Department of History, University of Michigan, Ann Arbor, Michigan, 48104.

Contributions should be clearly typed with double spacing and wide margins. Illustrations may be included by arrangement with the editors. Footnotes should preferably be typed separately, double spaced and should be confined as far as possible to references supporting quotations and statements in the text.

It will be appreciated if manuscripts are accompanied by a stamped, addressed envelope.

Contributors will receive 50 separate offprints bound in the journal covers. Any further offprints required must be ordered on receipt of the proof of the article.
