PROGRAM SUMMARY

Papers belong to either of three categories: (1) The Main Theme, "The Changing State and Its Interaction with National and International Society"; (2) Research Committees and Study Groups; or (3) Special Sessions.

1. The sessions of the Main Theme (including a plenary session at the beginning of the World Congress, a plenary session at the end) have been organized by the Program Committee of the International Political Science Association and approved (with revisions) by the Executive Committee on four subthemes: (i) State and Government in Recent Political Theory; (ii) The Changing Structure of the Governmental Apparatus; (iii) Comparative Public Policy and Governmental Actions; and (iv) Global Problems: Challenges to the State.

2. The sessions of the Research Committees and Study Groups have been organized by their Executive Committees. Each Research Committee is permitted to develop one section comprising two sessions, each Study Group is permitted to organize one session.

3. The Special Sessions are organized at the request of members of the Association. A session is defined as a morning or afternoon period of approximately 2½ hours. The Congress guidelines indicate that no more than four papers should be presented per session. Proposals for Special Sessions must come from individual members of the Association and must have been made to the Special Session Coordinator, Francesco Kjellberg, prior to February 1, 1984. The major criteria is that the individual(s) proposing

the session must indicate its basic content and be sure that the topic is of international interest.

THIRD PART

The Special Sessions

At the 1985 World Congress, about one-third of the sessions (30 to 35 sessions) will be organized as Special Meetings. Special Meetings should concern topics of significant interest cross-nationally to active political scientists. Each panel should have several papers reflecting international standards of scholarship. Collectively, the panels provide representation for scholars not working in the fields emphasized by the special theme of the Congress, "The Changing State and Its Interaction with National and International Society," thus contributing to a balanced program of overall broad interest.

GUIDELINES REGULATING PARTICIPATION

1. The program will consist of three parts:

1.1. Sections and Plenary Sessions under the Main Theme, comprising 60 to 70 sessions.

1.2. Sections organized by IPSA Research Committees and Study Groups. Each Committee will normally organize two sessions and each Study Group one session.

1.3. Special Meetings proposed by IPSA members, which will normally consist of one session each. The Program Committee may accept 30 to 35 such sessions.

2. The Main Theme of the program is: The Changing State and Its Interaction with National and International Society.

2.1. The Main Theme is subdivided into four subthemes: (I) State and Government in Recent Political Theory; (II) The Changing Structure of the Governmental Apparatus; (III) Comparative Public Policy and Governmental Actions; (IV) Global Problems: Challenges to the State.

2.2. Each subtheme has a consultant, who will generally advise the Program Chairperson and, when requested, aid in solving problems within their own subtheme.

3. In order to facilitate communications and decision-making and the preparation of proposals to be submitted to the Program Committee and to the Executive Committee, a Planning Committee has been constituted.

3.1. Such Committee is formed by the IPSA President, a member of the French Organizing Committee, the Program Chairperson, the Program Vice-Chairperson and the IPSA Secretary-General.

3.2. The administrative facilities for the Program, to be performed in close contact with the IPSA Secretariat, will be located in Paris.

4. The Program Chairperson will have the following responsibilities:

4.1. He will be in charge of coordinating

and distributing all relevant information as well as proposing decisions to the Program Committee and the Executive Committee, in matters pertaining to the intellectual organization of the Congress.

4.2. In consultation with the respective Theme Consultants he will make decisions, or propose them when pertinent to the Program Committee or the Executive Committee, about any issue arising during the process of organizing sections or sessions, including replacements of Section Convenors who for any reason cannot, or are failing to, perform their duties.

4.3. He will be responsible for gathering, inducing, and processing proposals for the third part of the Program, Special Meetings.

5. The Theme Consultants will have the following responsibilities:

5.1. In cooperation with the Program Chairperson they will propose Section Convenors in the framework of the Main Theme and subthemes of the program.

5.2. They will organize together with Co-convenors Subtheme General Sessions, focusing on a broader topic within each subtheme.

5.3. In case of disagreement between the Subtheme Consultants and the Program Chairperson, the pertinent decision will be made by the IPSA President.

6. The organization of the sections within the Main Theme, each comprising two sessions, will be the responsibility of Convenors in collaboration with Co-convenors.

6.1. The Section Convenors will coordinate all aspects of their sections. They are responsible for initiating all organizational matters for their sessions and preparing proposals which will be submitted for consultative purposes to the Co-convenor. But, it is the Convenor who is responsible for correspondence and contacts with participants, the Program Chairperson and IPSA Secretariat.

6.2. In addition to the paramount concern with quality of scholarship, the Section Convenors will strive to obtain a balanced representation of the diverse approaches, regions, political systems,

sex, age, and other criteria springing from the plurality embodied in IPSA and discipline.

6.3. The Convenors will inform the Program Chairperson and the respective Subtheme Consultants of developments and problems in their sections: selection of Chairpersons for sessions, selection of papergivers and discussants, possible replacements or additions of papergivers, titles and content of papers, and other matters relevant to the successful functioning of their sessions.

6.4. The Convenors should not reach closure prematurely on participants, in a way that forecloses the possibility for interested scholars to put forward proposals for papers or volunteer their participation in other capacities. However, the Convenors should forward the names and addresses of the Chairperson of their sessions to the Program Chairperson and the IPSA Secretariat *no later than February 15, 1984*, and the program for the sections (title of papers, names and addresses of papergivers, and discussants), *no later than June 15, 1984*.

6.5. If more high quality papers are offered to the Convenors than can be accommodated in a session, the Convenor may name these authors as "Submitted Paper Participants." Special letters of invitation will be written where necessary. They will not be listed in the official program, but they may on the Convenors' (Session Chairpersons') discretion, be given the opportunity to present their papers.

6.6. The Convenors are responsible for circulating a list with names and addresses of the Session Chairpersons, papergivers and discussants to the participants in their sections.

6.7. In the event of any problem or dispute that the Convenors cannot resolve with respect to the respective Section, the pertinent decisions will be made by the Program Chairperson, in consultation with the Subtheme Consultants.

6.8. The Convenors will submit by September 15, 1985, a short report on the proceedings of their sections to the IPSA Secretariat.

6.9. *The Convenors are required to pay*

their registration fee by February 1, 1985.

7. The Session Chairpersons are responsible for conducting the sessions, and should make every effort to maximize the opportunity for discussion in their session. This implies:

1. restricting each paper giver to a maximum of 15 minutes of his/her oral presentation;
 2. restricting to no more than 30 minutes the period reserved for discussants and the responses of papergivers;
 3. allowing at least one hour for general discussion from the floor; and
 4. following judicious practices in eliciting comments and questions from those attending the session.
5. Chairpersons are requested not to permit lengthy and irrelevant interventions.

The Session Chairpersons are required to pay their registration fee by February 1, 1985.

8. Only seven names, including the Chairperson (eight if Co-Chairperson), may be listed for any one session (two and one-half hour in length). Normally, there will be no more than four papergivers.

9. The responsibilities of the Papergiver in a session are as follows:

9.1. The Papergiver should prepare a written paper in English or French of no more than 25 typewritten pages (8½ x 11) (A-4) single-spaced and typed on one side of the page only.

9.2. The Papergiver must send a 125-word abstract of his/her paper in English or French to the Program Chairperson, Francesco Kjellberg (Institute of Political Science, University of Oslo, 1097 Blindern, N-Oslo 3, Norway) and to Serge Hurtig (Fondation nationale des sciences politiques, 27 rue Saint-Guillaume, 75341 Paris, Cedex 07, France) *no later than February 1, 1985.* Instructions to facilitate the standardization of these abstracts will be sent to each papergiver.

9.3. Copies of the paper should be sent, *no later than March 15, 1985* to: (1) the Section Convenors; (2) all listed participants in the relevant section; (3) the Sub-theme Consultants; (4) the Program Chairperson; and (5) the IPSA Secretariat in Ottawa.

Papers submitted after the deadline may not be listed in the official program nor in its Book of Abstracts; in these cases, the Section Convenor shall decide whether or not to permit the paper to be presented orally in the respective section.

9.4. The Papergiver is responsible for getting to the World Congress Paper Room at least 50 copies of his/her paper and addressed as follows: The Paper Room, XIIIth IPSA World Congress, Fondation nationale des sciences politiques, 27 rue Saint-Guillaume, 75341 Paris, France.

9.5. *A person who has not paid his/her registration fee by February 1, 1985, will not have his/her name printed on the program.*

10. The Program Chairperson will process and evaluate proposals for Special Meetings, as well as submit to the Program and Executive Committee the general criteria and the specific decisions concerning approval of Special Meetings in the Congress.

11. Requests from Research Committees and Study Groups should be addressed to the Program Chairperson, who will be responsible for informing and proposing decisions, whenever pertinent, to the Program Committee.

12. To permit maximum participation in the World Congress, it is necessary to limit the number of appearances of any single individual. Accordingly,

1. Any individual may make no more than one appearance on the program in each of the following categories: (i) convenor of a section; (ii) chairperson of a session; (iii) papergiver; and (iv) discussant.

2. That is, a person may convene a section, chair one of its sessions (or some other session), present a paper and serve

as a discussant; the person may not chair two sessions or act as a papergiver or discussant in two sessions.

3. In calculating such appearances, the entire program (including the Main Theme sessions, Research Committee

and Study Group sessions and Special Meetings) will be taken into consideration. The Program Chairperson may waive this rule for the Plenary Sessions and the Subtheme General Sessions.
