private universities and colleges, government, and research organizations. Lecturers are selected by a faculty committee from the College's Social Sciences Program. It is the Series' intention to support the work of promising young scholars.

Each lecture consists of a 45-minute formal presentation on a topic which will later be expanded into a book of approximately 125 pages. The lecturer is also considered a visiting scholar who is expected to visit appropriate classes and meet with faculty and staff at the College for a day.

The Lecture Series, through its contractual agreement with Rutgers University Press, provides a subsidy for the publication of each manuscript. The publication agreement identifies the College Association at Delhi, a non-profit corporation, as the author of record. The College Association subcontracts to each lecturer for a manuscript. Rutgers University Press determines the acceptability of each manuscript. Initially, a portion of the royalties from each published manuscript is paid back to the Sanford-Erpf Series. All royalties thereafter are assigned by the College Association to the lecturer.

The Lecture Series provides each lecturer a stipend, half of which is paid when the lecture is delivered (excluding lecturer's expenses); the other half is paid when an acceptable manuscript is submitted for publication.

## 1979-80 Judicial Fellows Program

Political scientists are invited to apply for the 1979-80 Judicial Fellows Program. The Program, patterned after the White House and Congressional Fellowships, attracts outstanding talent from multi-disciplinary backgrounds. Two Fellows will be chosen to spend 1979-80 observing and contributing to projects attempt-

ing to improve judicial administration. An additional purpose of the Program is to promote those individuals who will not only make a contribution during their year as Judicial Fellows, but who will continue to make a contribution to judicial administration in the future.

Now entering its seventh year, the Program is administered by the National Academy of Public Administration. It was instituted through grants from the American Bar Endowment, the Ford Foundation, and the Edna McConnell Clark Foundation.

Candidates should have at least one postgraduate degree, at least two years of professional experience, and preferably, familiarity with the judiciary. Stipends for the Fellowships will be based on comparable government salaries. The Fellowships begin in September, 1979, and have a duration of one year. The application deadline is November 3, 1978.
