EDITORIAL POLICY FOR THE JOURNAL

Beginning in 1990, comments on articles and replies, as well as comments on paleontological subjects of general interest, will be considered for publication in the Journal on a limited basis. These should be sent directly to the Managing Editor and will be published at his discretion.

Also beginning in 1990, authors of manuscripts submitted for publication in the Journal are invited to suggest two or three potential reviewers conversant with the subject.

Authors are reminded that all figures must be submitted at publication size (18.3 × 23.3 cm, page size; 18.3 cm, double column width; 9.0 cm, single column width). Each figure must be mounted on an appropriate 8½ × 11 inch (21.5 × 28 cm) backing. Single weight, white posterboard is sufficient. Leave a minimum of 19 mm (0.75 in.) above each figure for labeling for the printer.

Additional instructions are to be found on the inside back cover of the Journal and in the article by Hoare and Steinker (1987) cited therein.
