## New Appointments

**Norman Beckman** has been appointed as Director of the Council of State Government's Washington, D.C. office.

**Lawton Bennett**, associate professor, University of Texas at Tyler.

**Eugene Lewis** resigned as Provost of New College of the University of South Florida effective September 1, 1982. He will assume full-time status as professor of political science.

**Donald G. Tacheron** has been elected vice president for research by the board of directors of Congressional Information Service, Inc. (CIS), a Washington, D.C. area publisher. Previously he served as the company's director of research.

Since joining CIS in 1980, Tacheron has played a key role in the development of two major new CIS services: the CIS Legislative History Service, which was introduced in the fall of 1981; and the Index to International Statistics, scheduled to begin publication in January 1983.

Tacheron's background includes extensive experience with the U.S. Congress and in the field of legislative research. He

has served as associate director of the American Political Science Association, deputy director of the Legislative Reference Service (now Congressional Research Service) of the Library of Congress, director of research for the Joint Committee on Congressional Operations, and staff director of the Senate Ad Hoc Committee on Legislative Immunity. He is co-author (with Rep. Morris K. Udall) of the book, *The Job of the Congressman*.

CIS is a leading publisher of information access and retrieval systems. Its products are widely used by libraries, government agencies, businesses, law firms, and research organizations. The company is a subsidiary of Elsevier-NDU nv, The Netherlands.

**Annamarie Hauck Walsh** has been appointed president of the Institute of Pub-

lic Administration (IPA). **Lyle C. Fitch**, who is retiring as president, will become chairman of the board. IPA's chairman, **Luther Halsey Gulick**, will become chairman emeritus.

Walsh received her doctorate in political science from Columbia University. She first came to the Institute of Public Administration in 1960 as editor of *Metropolitan Area Problems: News and Digest*. She is the author of *The Public's Business: The Politics and Practices of Government Corporations* (MIT Press, 1978). Walsh has directed numerous research and consulting projects at IPA, including a 13-nation case study of urban services management for the United Nations and reorganization and management studies for public enterprises. She was staff director of the Governors' Task Force on the Future of the Tri-State Regional Planning Commission (New York, New Jersey and Connecticut). She has been a member of the National Academy of Public Administration since 1972.

Since January 8, 1982, **Linda P. Brady** has served as Defense Advisor on the U.S. Delegation to the Negotiations on Intermediate-Range Nuclear Forces (INF) in Geneva, Switzerland. Following the spring 1982 round of negotiations, she returns to the Europe Division of Program Analysis and Evaluation in the Office of the Secretary of Defense.

Research Triangle Institute (RTI) has promoted **Thomas J. Cook** to the new position of senior scientist in RTI's Center for Population and Urban-Rural Studies.

A senior political scientist at RTI since 1976, Cook previously held a tenured faculty post at the University of Illinois in Chicago. He specializes in research on program evaluation and performance measurement systems for public agencies, and has headed major Research Tri-

angle Institute studies for the National Institute of Justice, the Safer Foundation, the National Bureau of Standards, and the U.S. Department of Agriculture's Food and Nutrition Service.

Cook is an adjunct professor of political science at the University of North Carolina at Chapel Hill, and is an advisor to the public administration program at North Carolina State University. He has recently been appointed to the Political Science Program review panel of the National Science Foundation.

**Patricia S. Florestano**, director of the University of Maryland's Institute for Governmental Service, has been elected the new President-Elect of the American Society for Public Administration (ASPA). She is the second woman to serve in this position in ASPA's history of more than 40 years.

Dedicated to better government and improved public service, ASPA is a national organization with 111 chapters. Its more than 18,000 members include practitioners in all levels of government, academicians, students, and business and community leaders.

The University's Institute for Governmental Service, formerly called the Maryland Technical Advisory Service, helps local governments and agencies of the State of Maryland solve problems in governance and administration. Florestano has been director of the institute for almost two years. She also is chairperson of the governing board of the National Urban Affairs Association and a member of ASPA's National Council. She has served on task forces for the Southern Growth Policies Board, the Lincoln Institute, and the U.S. Department of Housing and Urban Development.

Florestano also is an adjunct professor in the University's Institute for Urban Studies. A resident of Crofton, Maryland, she received her bachelor's, master's, and doctoral degrees from the University of Maryland.

In 1982 the Department of Political Science at the University of Michigan will award the first **Gerald R. Ford Fellowship** in American Government and Politics to an incoming graduate student

of promise in that field of study.

When Mr. Ford was inaugurated as Vice President of the United States in 1974, a medal was struck to honor the occasion. The Vice President presented the proceeds from the public sale of the Ford Vice Presidential Inaugural Medal to the University of Michigan, his alma mater. Those funds were used to establish the Ford graduate fellowship.

President Ford has served as adjunct professor of political science at the University of Michigan. In 1961, then Congressman Ford received the Distinguished Congressional Service Award from the American Political Science Association.

**Margaret Hamilton**, professor of government, College of William and Mary, is on leave this year studying the reorganization of government operations in France.

**Afak Haydar** has been appointed Director of International Programs at Arkansas State University. The position, which he holds in addition to his departmental appointment, involves overseeing ASU's rapid expansion into the international student education field, with major contracts including ones with Saudi Arabia and Malaysia.

**Chun-tu Hsueh**, professor of politics at the University of Maryland, was invited to attend the commemoration meetings of the 70th anniversary of the 1911 Revolution in China last October. In Peking, he met almost all the Party, government and the PLA leaders, including Ye Jianying and Deng Xiaoping.

**Morris McCain**, assistant professor of government at the College of William and Mary, is on leave this year to study arms control at Harvard's Center for Science and International Affairs under the auspices of the Ford Foundation.

**Roy E. Miller**, associate professor, Southern Illinois University at Carbondale, and **David A. Bositis**, assistant professor, George Washington University, are the recipients of the Pi Sigma Alpha Award for the best paper presented at the 1980 annual meeting of the Southwestern Political Science Association for their paper entitled "Social Psychological

Characteristics and Telephone Interviewer Effectiveness."
